Qualifications to Serve on Ballot Question Committee:

Mr. Van Epp has more than three decades of experience in real estate development and management.

Mr. Van Epp is a former Senior Vice President of The Rouse Company and President of its affiliate - The Howard Hughes Corporation. For Rouse, he was responsible for West Coast Community Development, most notable for its 22,500-acre master-planned community of Summerlin in Las Vegas. Since 1996, Van Epp has led teams that developed land for 21,000 homes, selling more than \$1 billion worth of land. He also developed more than two million square feet of office and retail space in the communities for which he was responsible.

Most recently, Mr. Van Epp was executive vice president and chief operating officer of Newland Communities, the nation's largest privately held developer of residential master-planned communities. He had overall responsibility for the operating regions of Newland Communities and its Regional Presidents nationwide responsible for existing community development and operations as well as new start-up communities.

Mr. Van Epp is a three-term Trustee of the Urban Land Institute (ULI) and is past President of the Board of Governors of the Summerlin Hospital Medical Center, and is past Chairman of the Executive Council of the UNLV Foundation Board of Trustees.
