Dear Ms. Thomas:

As you may know, Burglar Alarm licenses are privilege licenses which require a background investigation and approval by the Las Vegas City Council. In November 2007, the City Council approved a temporary license for Pinnacle Security, LLC to begin conducting business while the principals, Steven Zolman, Kelly Walker and Jared Chappell were undergoing their investigations. Subsequent to the completed investigations this office issued a permanent Burglar Alarm license on February 7, 2008. Las Vegas Municipal Code (LVMC) 6.06.060 requires each principal to be investigated and approved for suitability. Earlier this year this office accepted an application for suitability from Jonathon Izatt as key employee and processed the application in accordance with LVMC 6.06.060. On May 21, 2008 Mr. Izatt withdrew his application, but a new key employee application was submitted for Moses Hawkins that same day.

After several months of attempts to conduct an investigation on Mr. Hawkins the Las Vegas Metropolitan Police Department (Metro) has closed this case due to the failure of the applicant to cooperate in the investigation. Attempts by the case detective to mitigate this issue by contacting you have failed due to you being non-responsive by telephone or in written form.

This letter is to formally advise you that the aforementioned business license is being **declined for renewal** effective February 1, 2009 for the following reason:

LVMC 6.02.090 (2) (H) which states,

(h) The business activity constitutes, promotes, causes, allows, fosters, aids, or otherwise enables a private nuisance, public nuisance or chronic nuisance, or has been or is being conducted in an **unlawful, illegal or impermissible manner**, including but not limited to causing, allowing, promoting, fostering, aiding, enabling, exercising deliberate ignorance towards or failing to abate a private nuisance, public nuisance or chronic nuisance; or (Emphasis added)

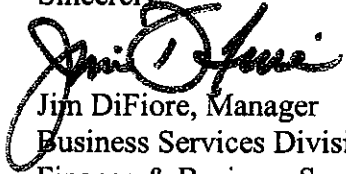

The business has operated for over a year without an approved local key employee as a principal of this business. This is a violation of both LVMC 6.02.090 (2) (H) and LVMC 6.06.060.

You have a right to appeal this decision according to LVMC 6.02.110 within thirty days to the City Council by filing written notice of appeal with the Department of Finance and Business Services. The City Council shall hear the applicant at the next regularly scheduled meeting following the expiration of ten days after the applicant filed a notice of appeal.
