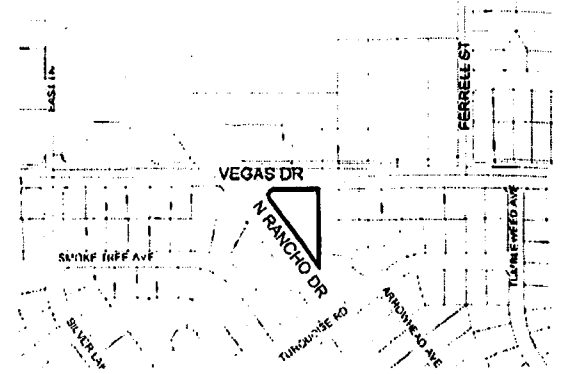

Application Location



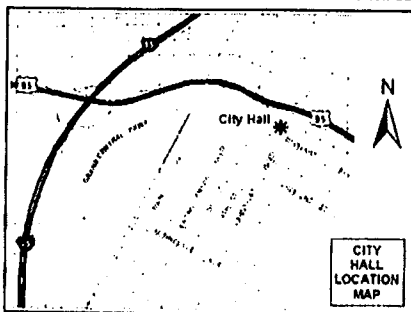
