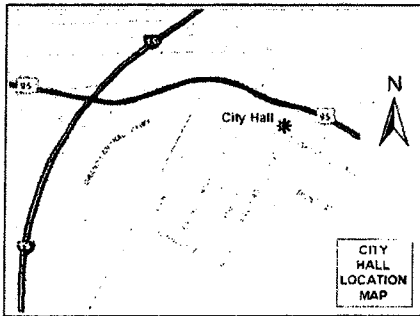
*This would create too much traffic

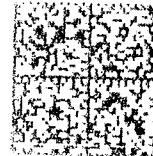

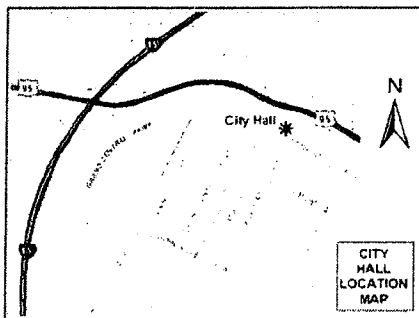
