PURPOSE/BACKGROUND:

This project consists of two lots: Lot I, Meadows Alta Parallel Project Phase II provides for approximately 11,000 feet of new storm drain facilities and replacement of approximately 1,300 square feet of storm drain in Alta Drive. Lot II, Brush Street Storm Drain includes improvements of approximately 651 feet of storm drain. Funding for this project is provided by the Clark County Regional Flood Control District.
