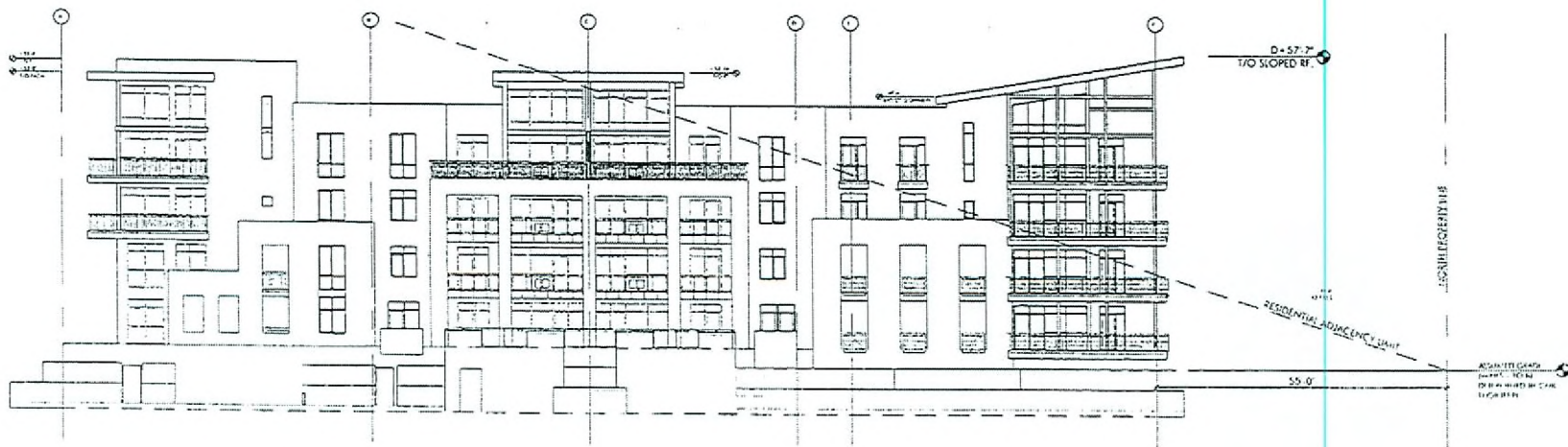

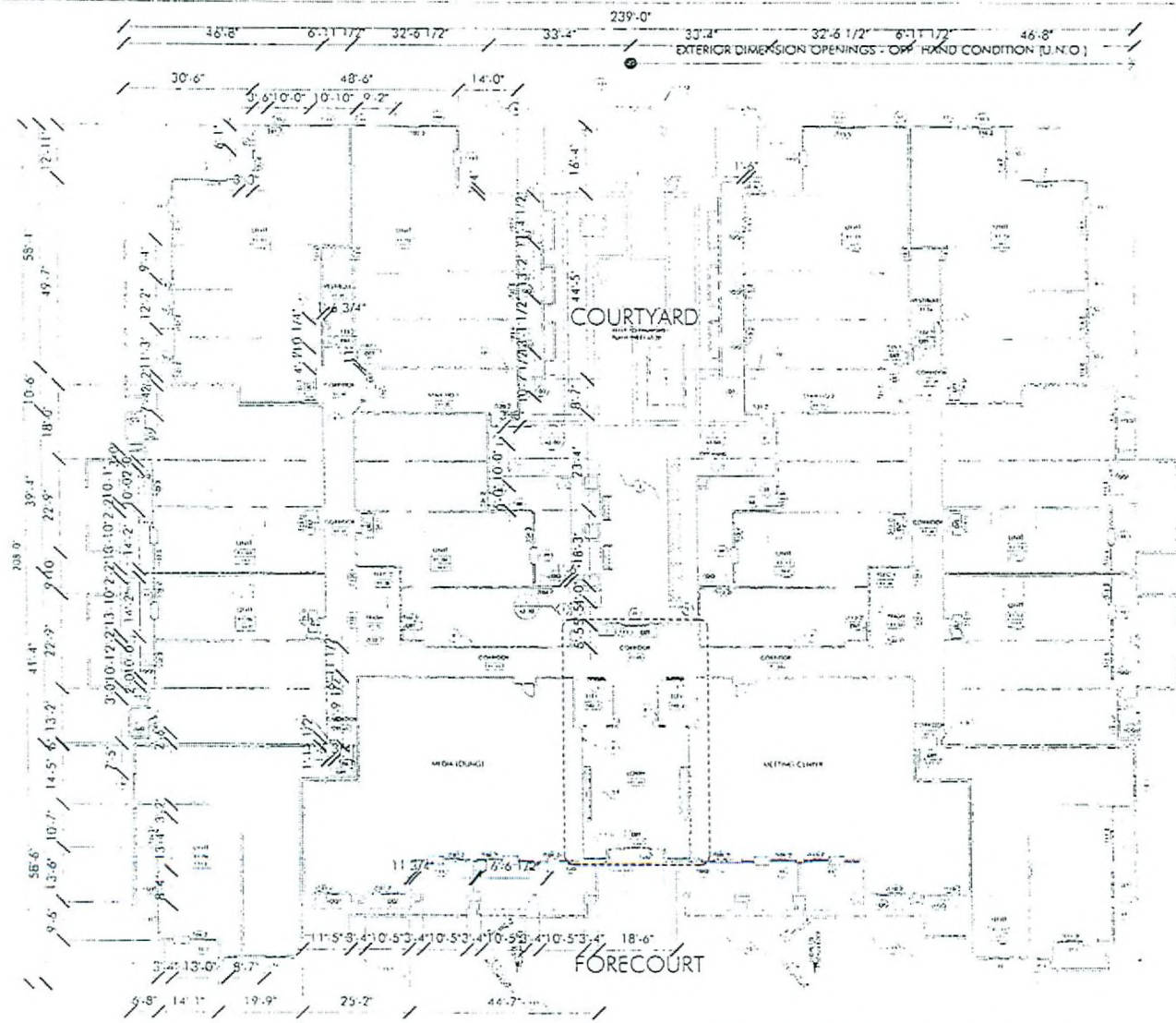


RESIDENTIAL ADJACENCY HEIGHT LINE

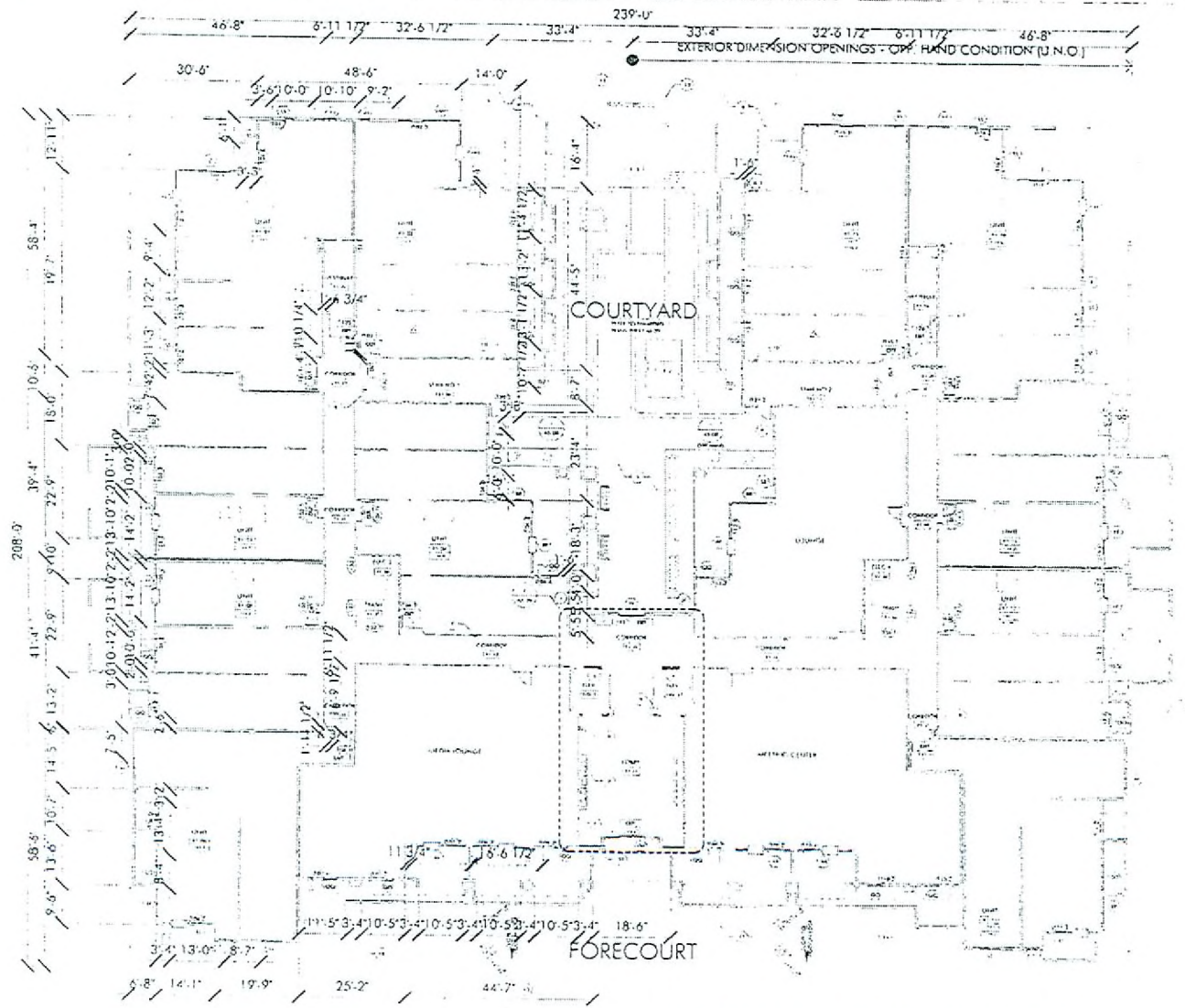
