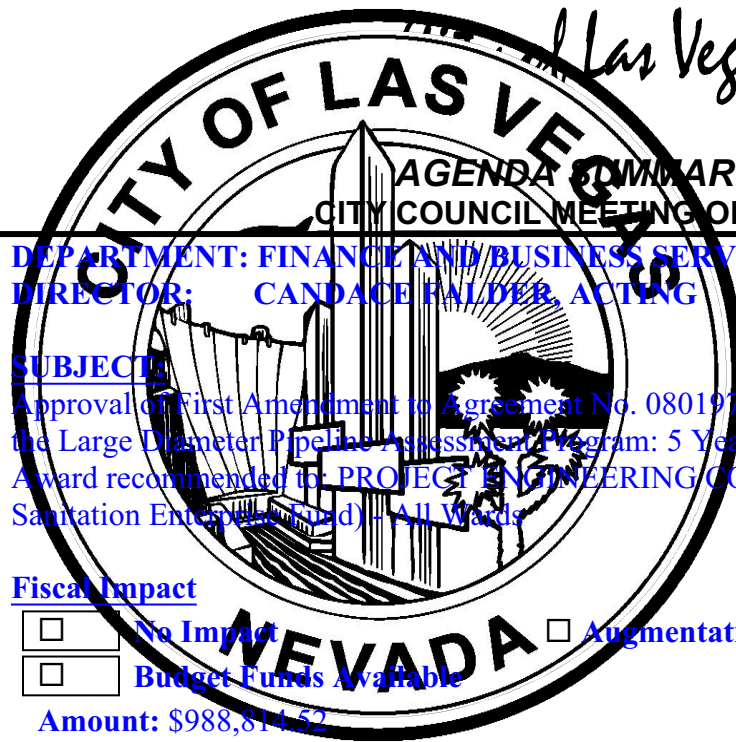

PURPOSE/BACKGROUND:

On February 20, 2008 City Council approved Year 1 of the 5 year program for consultant to provide the inspection, cleaning and evaluation of the condition of sewer pipeline that is older than ten years old and 15 inches in diameter and larger, with four one-year options to renew. This amendment provides for Year 2 of the program to include the assessment of approximately 161,252 feet of sewer pipeline and 447 manholes. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
