

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 4
ITS COMMUNICATION INFRASTRUCTURE PROJECT**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 4 made and entered into this 6TH day of May, 2009 by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY", the COUNTY OF CLARK, hereinafter referred to as "COUNTY" a political subdivision of the State of Nevada and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

WITNESSETH

WHEREAS, pursuant to Chapter 373 of the Nevada Revised Statutes, a Project to design roadway improvements for ITS Communication Infrastructure Project located partially within the CITY, and partially within the COUNTY has been approved by the Regional Transportation Commission.

WHEREAS, the parties have executed an Interlocal Contract dated March 11, 2004 and Supplemental Interlocal Contracts dated October 14, 2004, September 8, 2005 and March 13, 2008 for improvements needed to provide fiber optics interconnect conduit and fiber optic cable; and

WHEREAS, the CITY wishes to extend the project completion date.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, the RTC authorizes the CITY to proceed with the PROJECT as it is mutually understood and agrees as follows.

SECTION III – GENERAL paragraph 7 shall be revised to read as follows:

7. The project must be completed to the satisfaction of the RTC prior to June 30, 2011.

RTC may at any time thereafter grant time extensions or terminate this Contract and require all sums advanced to the CITY be reimbursed.

The remainder of the Interlocal Contracts dated March 11, 2004, October 14, 2004, September 8, 2005, and March 13, 2008 shall remain unchanged.

IN WITNESS WHEREOF, this Supplemental Interlocal Contract No. 4 is effective as of the date first set forth above.
