

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1
ARTERIAL INCIDENT AND EVENT MANAGEMENT SYSTEM**

CONTRACT # 500a

THIS FIRST SUPPLEMENTAL INTERLOCAL CONTRACT, made and entered into this ____ day of _____, 2008, by and between the Regional Transportation Commission of Southern Nevada, hereinafter referred to as RTC; the City of North Las Vegas, a municipal corporation, hereinafter referred to as CITY; the City of Las Vegas, a municipal corporation, hereinafter referred to as LAS VEGAS; and the County of Clark, a political subdivision, hereinafter referred to as COUNTY, organized pursuant to Chapter 373 of the Nevada Revised Statutes and Chapter 4.04 of the Clark County Code.

WITNESSETH

WHEREAS, RTC approved an Interlocal Contract on March 10, 2005, pursuant to Chapter 373 of the Nevada Revised Statutes, a Project to develop, design, perform construction inspection, construct, and evaluate Intelligent Transportation Systems (ITS) technologies for Craig Road, and Las Vegas Boulevard North, has been approved by the RTC; and

WHEREAS, the CITY desires to extend the completion date of the PROJECT.

NOW THEREFORE, in consideration of the covenants, conditions, agreements and promises of the parties hereto, the RTC authorizes the CITY to proceed with the PROJECT as it is mutually agreed and understood as follows:

SECTION I - SCOPE OF PROJECT

This interlocal applies to the development, design, and deployment of arterial incident and event management systems (*also known as an Intelligent Transportation Systems - ITS*) in the Craig Road, and Las Vegas Boulevard corridors. The PROJECT will develop, integrate and implement these ITS systems into the arterial management systems of the Freeway and Arterial System of Transportation (FAST), the Advance Traveler Information System (ATIS), and historical records maintained in the FAST Archived Data User System (ADUS). These systems will aid regional traffic operations through improved event management and improved traffic control and congestion relief through incident detection and verification while improving the safety and mobility of travelers throughout the metropolitan area.

The PROJECT will also include establishment of a fiber optic interconnect between existing communications paths along arterial streets and the FAST system. This will include connecting the Citizens Area Transit (CAT) Maintenance Station to the FAST fiber optic backbone.

SECTION III - GENERAL shall be changed as follows: Paragraph 7 is deleted in its entirety and replaced with:

7. The project must be completed to the satisfaction of RTC prior to June 30, 2009. The RTC may at any time thereafter grant time extensions or terminate this Contract and require all sums advanced to the CITY be reimbursed.

The remainder of the Interlocal Contract approved by the Regional Transportation Commission remains unchanged.

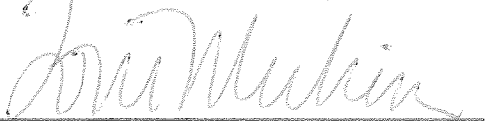

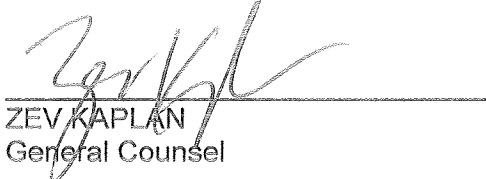
