INTERLOCAL CONTRACT

SPECIAL IMPROVEMENT DISTRICT HARDSHIP DETERMINATION

This Amendment Number 4 to the Interlocal Contract is made and entered into this _____ day of _____, 2009, by and between CLARK COUNTY, NEVADA, a political subdivision of the State of Nevada (hereinafter referred to as COUNTY), and the CITY OF LAS VEGAS, NEVADA, a Municipal Corporation of the State of Nevada (hereinafter referred to as CITY).

WHEREAS, COUNTY and CITY entered into the Interlocal Contract on June 21, 2005, for the Department of Social Service (CCSS) to assist in evaluating City-designated special improvement district (SID) hardship applications; and

WHEREAS, COUNTY and CITY entered into Amendment Number 1 to the Agreement on June 6, 2006, which renews and extends the Agreement through June 30, 2007; and

WHEREAS, COUNTY and CITY entered into Amendment Number 2 to the Agreement on June 19, 2007, which renews and extends the Agreement through June 30, 2008; and

WHEREAS, COUNTY and CITY entered into Amendment Number 3 to the Agreement on May 6, 2007, which renews and extends the Agreement through June 30, 2009; and

WHEREAS, Section III, Paragraph E, of the Interlocal Contract provides the option to renew the Interlocal Contract for four (4) one-year periods, upon approval by both COUNTY and CITY; and

WHEREAS, Section III, Paragraph G, of the Interlocal Contract authorizes amendments to the Interlocal Contract to be made upon mutual consent in writing by COUNTY and CITY; and

WHEREAS, COUNTY and CITY desire to continue the Interlocal Contract.

NOW, THEREFORE, for and in consideration of the premises contained herein COUNTY and CITY hereby agree to renew and extend the Interlocal Contract through June 30, 2010.

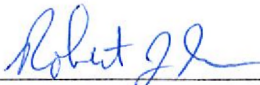

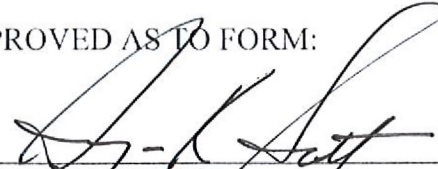
