Minutes:

JIM DiFIORE, Business Services Manager, stated NIR KAUFMAN has met the criteria for temporary approval of this locksmith license. MR. KAUFMAN currently has a temporary license in Clark County and has worked in the industry in Van Nuys, California, since 1992. MR. KAUFMAN had been informed of the current problems within the locksmith industry and MR. DiFIORE noted that he has a physical location and vehicles clearly stating the business' name. He recommended approval of the temporary license with a six-month review.
