B. If the licensee operates by donation or indirect method of payment, including remuneration that is at the discretion of the customer, the signage shall indicate such to the patron.

C. The rates published shall be the only rates charged.

D. The business shall be the only business operated from 2925 West Sahara Avenue address and not from any other location.

E. There shall not be any reference to a home telephone number as a contact number.
