CITY COUNCIL MEETING OF OCTOBER 1, 2008

Dear Mr. Sweeney:

The City Council at a regular meeting held October 1, 2008 APPROVED the request for a Special Use Permit FOR A HALFWAY HOUSE FOR RECOVERING ALCOHOL AND DRUG ABUSERS WITH WAIVERS TO ALLOW A 300-FOOT SEPARATION FROM AN EXISTING GROUP RESIDENTIAL CARE FACILITY WHERE 1,500 FEET IS THE MINIMUM SEPARATION DISTANCE REQUIRED AND TO ALLOW A 6,136 SQUARE-FOOT LOT WHERE 6,500 SQUARE FEET IS THE MINIMUM REQUIRED at 2621 Brady Avenue (APN 139-25-215-079), R-1 (Single Family Residential) Zone. The Notice of Final Action was filed with the Las Vegas City Clerk on October 2, 2008. This approval is subject to:

Added Condition:

- A. A landscape plan shall be submitted to Planning and Development for approval and implementation within 30 days.

Planning & Development

1. There shall be a six-month review at a public hearing of the City Council from the date of final approval of the Special Use Permit (10/1/2008).
2. No outside meetings shall be allows at this location for non-residents.
3. Conformance to all Minimum Requirements under LVMC Title 19.04.050 for a Halfway House for Recovering Alcohol and Drug Abusers use.
4. Approval of and conformance to the Conditions of Approval for Variance (VAR-29242) shall be required, if approved.
5. This approval shall be void one year from the date of final approval, unless a business license has been issued to conduct the activity, if required, or upon approval of a final inspection. An Extension of Time may be filed for consideration by the City of Las Vegas.
