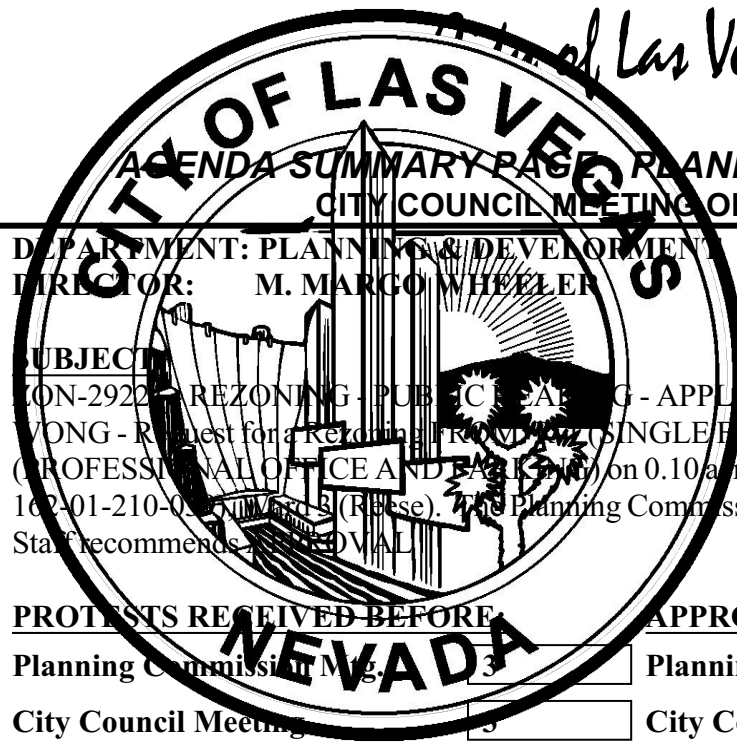

Minutes:

MAYOR GOODMAN declared the Public Hearing open for Items 120 and 121.

ROLANDO LADISLAO, 5112 West Charleston Boulevard, representing the applicants, stated that Eastern Avenue, between Charleston Boulevard and Sahara Avenue, only has about four properties zoned residential. With this trend, soon MR. and MRS. WONG will not be able to rent their home, especially to a family with children given the intense traffic. The owners previously spent about \$65,000 on the zone-change application, but it lapsed, resulting in the property being vacant for two years. The WONGS are doing a good job of maintaining the property, despite

having difficulties with the mortgage and it being upside down.

COUNCILMAN REESE preferred to hold this matter as he has several issues, such as parking and landscaping, he would like to discuss with the owners.
