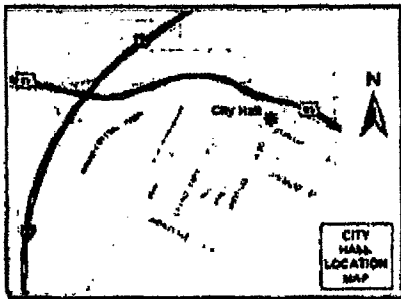

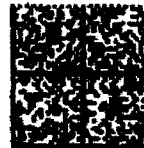

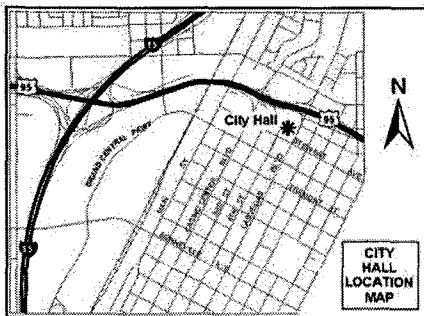

I OPPOSE this request to change this residential property to a business. We already have too many so-called businesses along Eastern Avenue that have been converted from residences. Most of these businesses are dealing as tax consultants. I counted twenty-one TAX establishments between Sahara and Charleston; that's way too many for one single purpose.

Most of these businesses do not have parking for their employees, so they use the residential streets for all-day parking. Often they take lunch breaks in their vehicles ... eating, drinking, etc., and when finished they discard their waste on the street or sidewalk where the items usually wind up in our yards.

Couple times last fall we had to communicate with the business at 1501 South Eastern. They were using a public address system to verbally advertise and play loud music. We don't need this type of noise in our residential neighborhood.

Driving along Eastern there are a lot of unoccupied buildings -- signs advertising FOR LEASE or FOR SALE. See lots of scrawled graffiti every where. Are the owners responsible to clean these walls? And, if so -- who enforces this rule?

Who approves of the building paint colors? Colors remind me of the businesses along the Mexican border, i.e., green, purple, orange, blue, red. Most of the signs on these buildings are written in Spanish. Is this America where English is the spoken language or Mexico?

How would you like to have some of these businesses in your residential neighborhood?

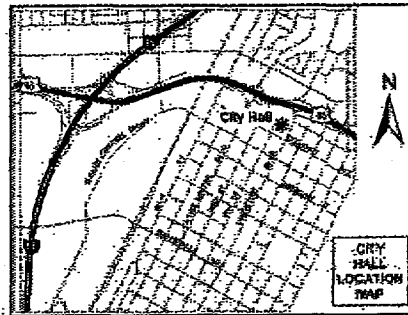
