Minutes:

JIM DiFIORE, Business Services Manager, stated this application was for an accessory massage use in an existing chiropractic business. DR. MARGARET COLUCCI is a member of the Chiropractic Board and he recommended approval subject to conditions which he read for the record.

DR. COLUCCI was present. She stated she has been Vice President of the Chiropractic Board for seven years and explained that the Massage Board would be handling the testing and background checks of massage therapists. This in turn resulted in the requirement that massage therapists be licensed by both the City and the State and that the chiropractors obtain the accessory massage use license.
