I know these are new owners, but the realtor or bank should have informed them that the structure did not have the necessary permits. If a variance is considered, it should be conditioned that they obtain the necessary building permits to bring it up to code.

When I represented the area as an assemblywoman, I filed complaints on the structure and on the fact they were originally acting as a group home without permission in the early 90's. I believe remodeling took place without permits and that at a minimum they should be required to obtain permits and code compliance.
