MAYOR GOODMAN declared the Public Hearing open.

RYAN ARNOLD, representing CBS Outdoor, explained that the parcel has been approved for another project, although it has been on hold due to the economic situation. He stated that the applicant is willing to accept a one-year review.

ASSISTANT CITY ATTORNEY BRIAN SCOTT advised that although the Municipal Code requires a minimum three-year review, since the applicant is agreeable, the Council has the discretion to institute a one-year review.
