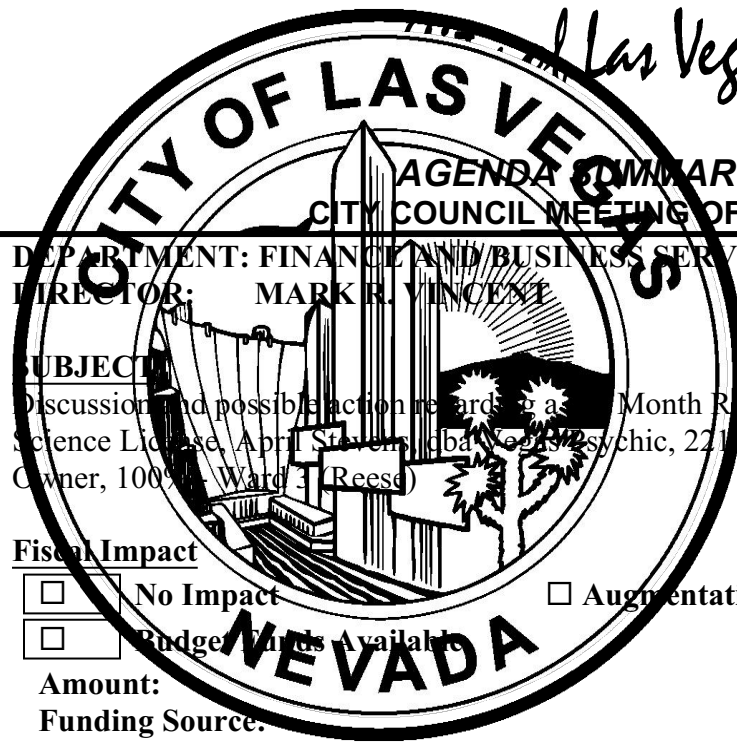

Minutes:

The applicant was not present.

COUNCILMAN REESE asked that the item be held in abeyance for two weeks, but after discussions with JIM DiFIORE, Manager of Business Services, and CITY ATTORNEY BRAD JERBIC, he extended the temporary license, which would have expired at midnight. The applicant was sent a certified letter informing her of this hearing. COUNCILMAN REESE indicated his intent to grant a permanent license but felt the applicant had to be present.

CITY COUNCIL MEETING OF: JUNE 3, 2009

CITY ATTORNEY BRAD JERBIC explained that only two temporary licenses can be issued and cannot exceed six months each. The Council could opt to trail the item at the end of the agenda to await the applicant. If action is not taken, the applicant will not have a license and would have to come back and reapply.

MR. DiFIORE suggested extending the temporary license for two weeks and allowing staff to contact the applicant and make sure she can attend. He verified for CITY ATTORNEY JERBIC that the applicant is at the end of the first six month temporary license. If the review is extended for 30 days, the applicant would either obtain the permanent license or lose this license and be required to start the process from the beginning.
