2 **ORDINANCE NO. _____**

3 AN ORDINANCE TO INCREASE THE REGIONAL SEWER CONNECTION CHARGE THAT
4 FUNDS THE CITY'S SHARE OF AN ALTERNATE CONVEYANCE SYSTEM TO BE BUILT
5 AND OPERATED BY THE REGIONAL CLEAN WATER COALITION, AND TO PROVIDE FOR
6 OTHER RELATED MATTERS.

7 Sponsored by: Councilman David W. Steinman

Summary: Increases the regional sewer
connection charge that funds the City's share of
an alternate conveyance system to be built and
operated by the regional Clean Water Coalition.

9 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
10 AS FOLLOWS:

11 SECTION 1: Title 14, Chapter 4, Section 320, of the Municipal Code of the City of
12 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

13 **14.04.320:** Subject to the provisions of Section 14.04.330, a regional sewer connection charge
14 shall be imposed on development within the City, [on and after October 1, 2006,] to be determined
15 as follows:

16 (A) For users other than large commercial users:

- 17 (1) Customer class of user is determined;
18 (2) Number of ERUs for user is determined;
19 (3) The regional sewer connection charge is calculated by multiplying the
20 applicable number of ERUs, commencing on:

- 21 [(a) October 1, 2006, by four hundred dollars;
22 (b) July 1, 2007, by eight hundred twelve dollars;
23 (c) January 1, 2008, by eight hundred twenty-four dollars;
24 (d) July 1, 2008, by eight hundred thirty-six dollars; and
25 (e) January 1, 2009, by eight hundred forty-nine dollars.]
26 (a) July 1, 2009, by eight hundred sixty-one dollars;
27 (b) January 1, 2010, by eight hundred seventy-four dollars;
28 (c) July 1, 2010, by eight hundred eighty-seven dollars;

- 1 (d) January 1, 2011, by nine hundred one dollars;
2 (e) July 1, 2011, by nine hundred fourteen dollars; and
3 (f) January 1, 2012, by nine hundred twenty-eight dollars.

4 (B) For large commercial users, the regional sewer connection charge is determined
5 by taking eighty-five percent of the estimated annual water usage, dividing by ninety thousand gallons,
6 and multiplying by the single family residence charge [(e.g., \$400 for the initial charge, \$812 as of July
7 1, 2007, \$824 as of January 1, 2008, \$836 as of July 1, 2008, \$849 as of January 1, 2009).], which is
8 the applicable charge set forth in Paragraph (3) of Subsection (A) of this Section.

9 SECTION 2: This Ordinance shall become effective on July 1, 2009.

10 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
11 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
12 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
13 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
14 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
15 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
16 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
17 invalid or ineffective.
