MAYOR GOODMAN declared the Public Hearing open for Items 81-87.

Regarding Item 87, COUNCILMAN BARLOW clarified for KATHERINE JOSEPH that the application is to vacate a portion of property to make it contiguous. BART ANDERSON, Public Works, explained that the school was built on an alley right-of-way in 1949. The vacation will
