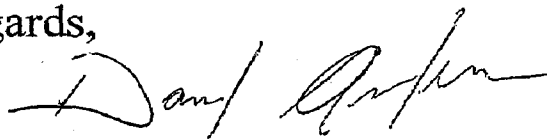
Dear Representatives,
