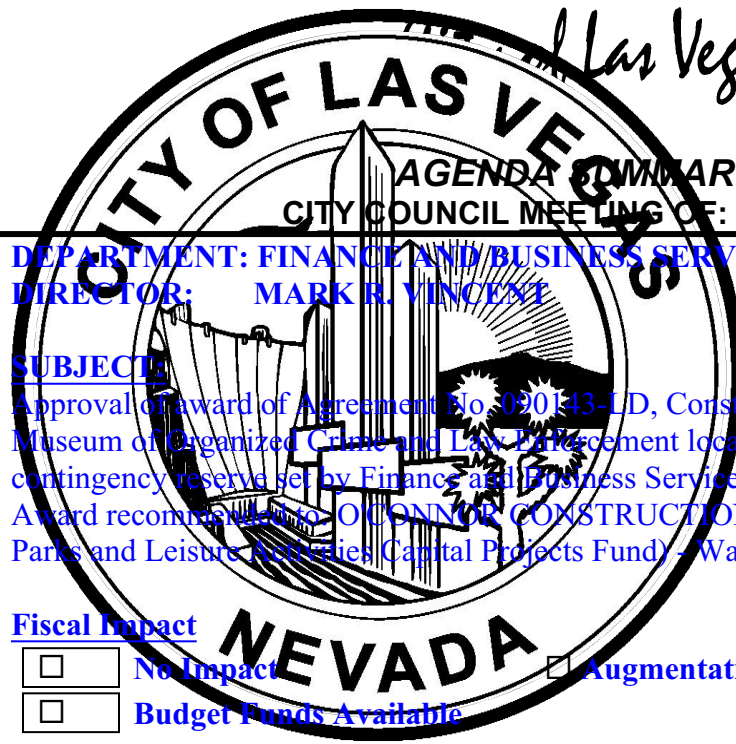

## CITY COUNCIL MEETING OF: AUGUST 5, 2009

### Minutes:

Items 28 and 30 were pulled from the Consent Agenda at COUNCILMAN ANTHONYS request.

COUNCILMAN ANTHONY stated he could not support this item because moving forward with the Museum of Organized Crime and Law Enforcement at this time would be fiscally irresponsible.

COUNCILMAN BARLOW described the ceremony held at the museum on August 4, 2009, and stated that it will be a wonderful attraction for locals and tourists. He looked forward to the opening in 2011.

COUNCILWOMAN TARKANIAN noted that the museum is funded with grants and not through the General Fund. The museum's emphasis will be on law enforcement and show how the law enforcement handles difficulties with crime. The term "Mob Museum" does not accurately portray the intent of the museum.

MAYOR GOODMAN explained that the historic US Post Office had been purchased from the National Parks Service to be used as a museum and subsequent studies indicated that a museum dedicated to organized crime would be the most attractive. MAYOR GOODMAN added that a renowned curator would be overseeing the museum and several important artifacts had already been obtained. The museum was expected to attract 600,000 visitors a year and was the right move for the City.
