

**SUPPLEMENTAL INTERLOCAL CONTRACT
STEWART AVENUE, MAIN STREET TO MARYLAND PARKWAY**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT, made and entered into this 5TH day of August, 2009 by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as the "RTC".

WITNESSETH

WHEREAS, RTC approved an Interlocal Contract on September 13, 2007 for a project to construct roadway improvements associated with the Stewart Avenue Rehabilitation, Main Street to Maryland Parkway, being located wholly within the CITY; and

WHEREAS, the RTC previously granted "Authorization to Proceed" for construction, engineering, right-of-way acquisition, and right-of-way other; and,

WHEREAS, the CITY desires to decrease funding for the Project.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, it is mutually agreed to supplement the Interlocal Contract for the Project as follows:

SECTION II – PROJECT COSTS: shall be revised to read as follows:

The RTC agrees to provide funding for project costs according to Section 6.1 REIMBURSEMENT COSTS of the Policies and Procedures Manual of the RTC within the limits specified below:

1. The total cost for construction, engineering, right-of-way acquisition, right-of-way other shall not exceed \$2,300,000.
2. The City will be issued a revised "Authorization to Proceed" for construction at a cost not to exceed \$1,800,000, engineering design at a cost not to exceed \$500,000, at the time written Authorization to Proceed is received from the RTC. The "Revised Authorization to Proceed" shall state a specific amount within the total estimated cost of the Project and, upon approval by the RTC, only that amount shall be encumbered and allocated.
3. A written request must be made to the RTC and an additional supplemental interlocal contract approved to allow exceptions to the adopted policies and procedures of the RTC or the amount noted above prior to payment of any additional funds.

The remainder of the Interlocal Contract dated September 13, 2007 shall remain unchanged.

IN WITNESS WHEREOF, this Supplemental Interlocal Contract is effective as of the date first set forth above.
