

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2
CENTENNIAL PARKWAY / GRAND MONTECITO PARKWAY
TRAFFIC IMPROVEMENTS**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2 made and entered into this 5th day of August, 2009 by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

WITNESSETH

WHEREAS, RTC approved an Interlocal Contract on April 12, 2007 and supplemental interlocal contract on April 9, 2009 for a project to design, purchase right-of-way, perform construction inspection and construct roadway improvements for Centennial Parkway / Grand Montecito Parkway Traffic Improvements, being located wholly within the CITY; and

WHEREAS, the RTC previously granted "Authorization to Proceed" for construction, engineering, right-of-way acquisition, and right-of-way other; and,

WHEREAS, the CITY desires to reduce total project funding.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, it is mutually agreed to supplement the Interlocal Contract for the Project as follows:

SECTION II - PROJECT COSTS shall be revised to read as follows:

The RTC agrees to provide funding for project costs according to Section 6.1 REIMBURSEMENT COSTS of the Policies and Procedures Manual of the RTC within the limits specified below:

1. The total cost for construction, engineering, right-of-way acquisition, and right-of-way other shall not exceed \$410,000 which includes all of the above.
2. A written request must be made to the RTC and an additional supplemental interlocal contract approved to allow exceptions to the adopted policies and procedures of the RTC or the amount noted above prior to payment of any additional funds.

The remainder of the Interlocal Contract dated April 12, 2007 and supplemental interlocal contract dated April 9, 2009 shall remain unchanged.

IN WITNESS WHEREOF, this Supplemental Interlocal Contract No. 2 is effective as of the date first set forth above.
