PURPOSE/BACKGROUND:

This bill will authorize the administrative extension of temporary licensing approval in certain cases where City Council action is unable to be taken in a timely manner through no fault of the licensee. The bill will also authorize the administrative reinstatement of alcoholic beverage licenses suspended or revoked for nonpayment of license fees. Such reinstatement will be available only within a limited time following suspension or revocation and will be subject to the payment of a reinstatement fee.

Minutes:

Second reading and bill adopted as amended as Ordinance No. 6054.

CHIEF DEPUTY CITY ATTORNEY VAL STEED stated that COUNCILMAN BARLOW had requested a Second Amendment which would change the reinstatement period for an alcoholic license that had been revoked for non-payment of fees from 90 days to 60 days. He recommended approval of a Third Amendment which would keep the reinstatement period at 90 days, but would only allow licenses that are revoked after July 1, 2009 to be eligible for reinstatement within 90 days.
