Public Comment on July 9, 2009 Planning Commission

On May 12, 2009, Don Rodriguez of Empire Land and Development made a presentation to the Bonanza Village Neighborhood Association regarding a development proposed by his client, Bashir Afzali, on Martin Luther King Jr. Boulevard, north of Washington Avenue. The proposed development is on the July 9, 2009 Planning Commission agenda as follows:

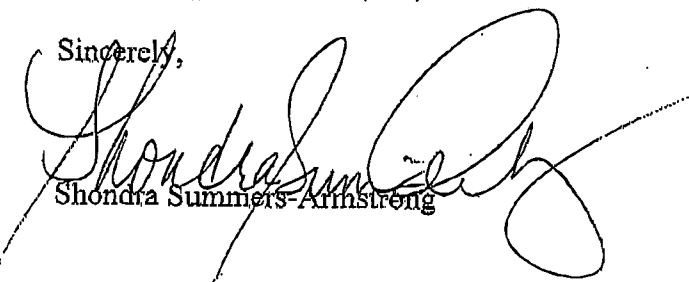
- Item 16. Abeyance - ZON 33765

There were 11 households represented at our neighborhood meeting. Seven households liked the project as presented, three households abstained and one household objected to the project.

The neighbors were concerned that the proposed development be visually appealing and congruent with the existing commercial plazas on either side of the subject property. There were also questions raised, but not clearly answered, about whether the developer had tenant agreements in place for this project; the neighbors do not want to end up with an unoccupied building on this site.

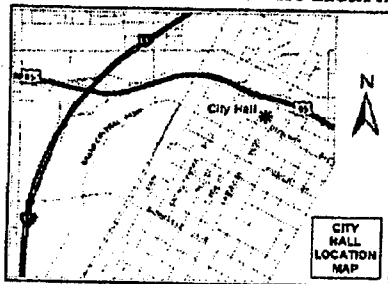

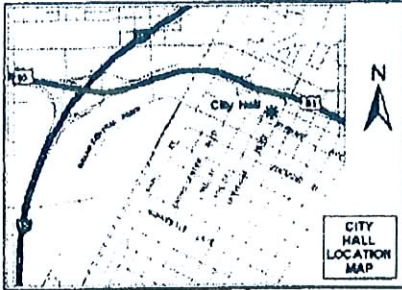

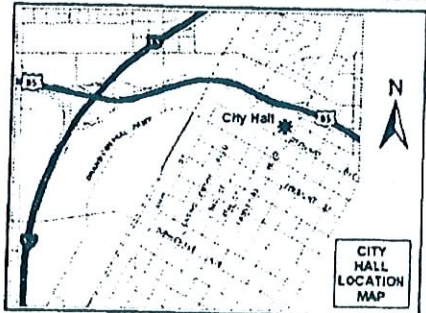
