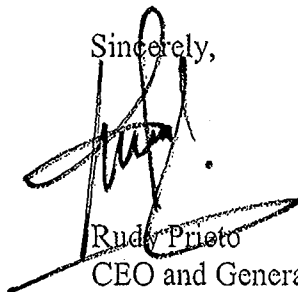
Dear Commissioners:
