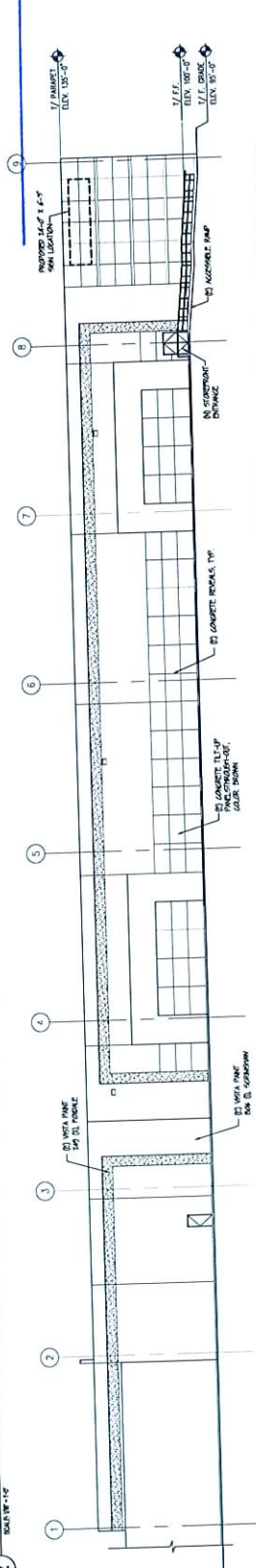
4 WEST ELEVATION

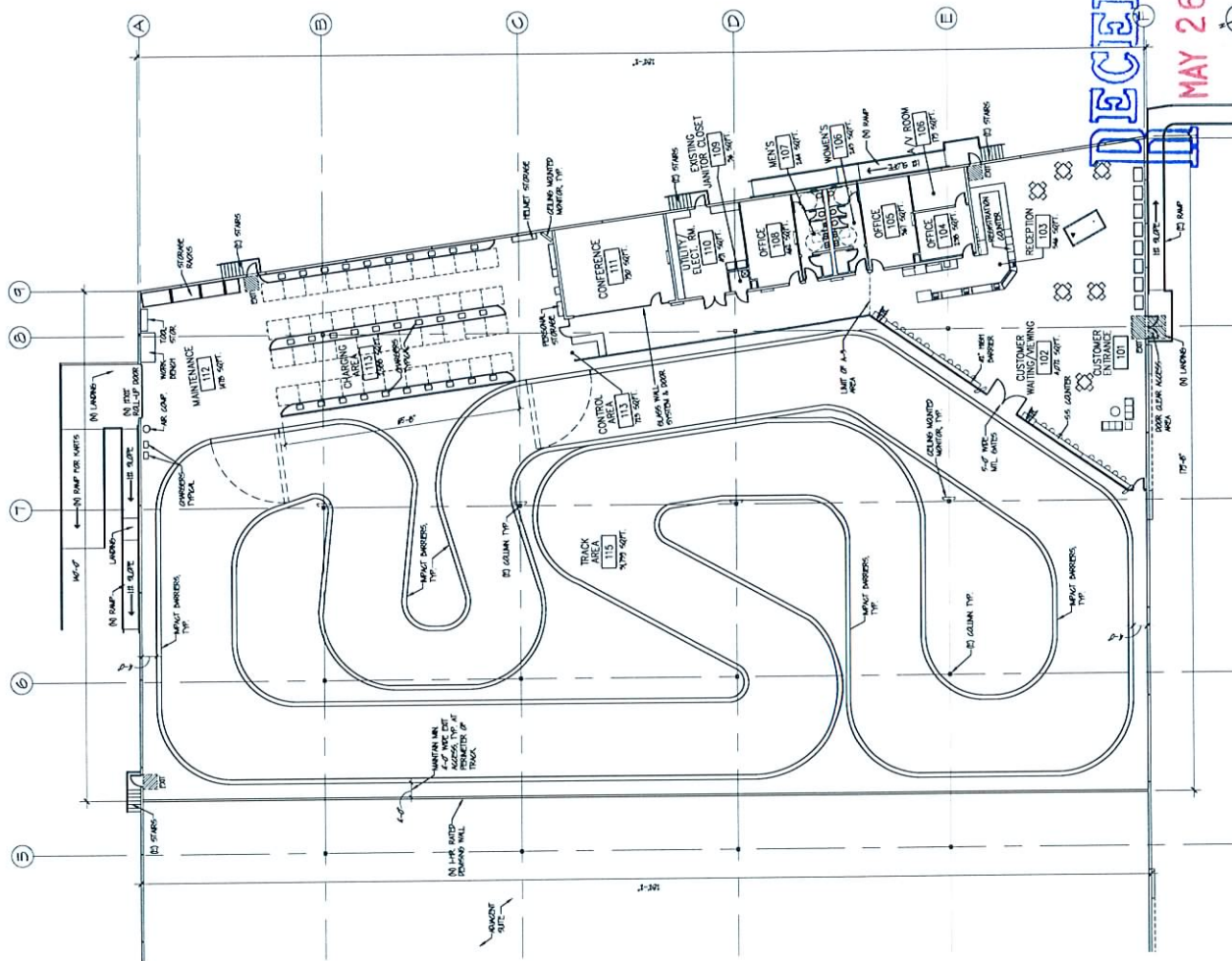
