Minutes:

MAYOR GOODMAN declared the Public Hearing open.

VICKY FRASIER WILLIAMS, Vice President of Imagine Schools in the State of Nevada, explained that the school has been in existence for one year and operating successfully out of the YMCA at Durango Hills with 40 students, and 100 pupils on the waiting list. Unfortunately, the YMCA is no longer spacious enough to handle both the staff and the students.

At the Mayor's request approximately ten staff members and others in support came forward from the audience. They requested approval to function out of Living Grace Church temporarily until a permanent site is found.

VERNON LAW, Vice President of Imagine Schools in the State of Nevada, stated that the schools track record speaks to the wonderful things it is doing in educating kids.

SEAN NEWSOME, Board Member of 100 Black Men of Las Vegas, requested approval and stated that the Imagine 100 Academy of Excellence is doing very well.

COUNCILMAN REESE noted that PASTOR RICHARD BOX, Living Grace Church, 4025 North Rancho Drive, has been an inspiration to him, and expressed his support of this application.

COUNCILMAN BARLOW commented that he trusts the Imagine 100 Academy of Excellence will continue to do a wonderful job at their new location as it has at the Doc Pearson Center.

At COUNCILWOMAN TARKANIAN'S request PASTOR BOX came forward and stated that Living Grace Church is partnering with Meadows Fellowship to provide them space for the school. COUNCILWOMAN TARKANIAN commended PASTOR BOX for all his accomplishments. MAYOR GOODMAN invited him to give the invocation at a future Council meeting.

COUNCILMAN ROSS advised that he received three protest and three support postcards, and noted that after thumbing through the material on the school, he regards the Imagine School program as fabulous and would like to have it available in all City wards.

MARGO WHEELER, Director of Planning and Development, recommended deleting Condition 5, opining that it was no longer necessary, and formulated an additional condition that the applicant agreed with.

MAYOR GOODMAN declared the Public Hearing closed.
