CITY COUNCIL MEETING OF: AUGUST 5, 2009

DAVE EDER, 777 East Quartz Avenue, appeared representing the applicant and accompanied by RUBEN ANAYA, Marianas Supermarket, 574 North Eastern Avenue. MR. EDER stated that the first Marianas opened as a little store in the same plaza on Bonanza Road and Eastern Avenue and the owner wishes to expand into the adjacent 8,000 square-foot former indoor swap meet building, which was bought by Mariano's. The existing location will be renovated. Marianas has been very successful and has various locations throughout the valley.

TEDDY RUSSELL said that Marianas is a great store and a great operation. He recommended approval.
