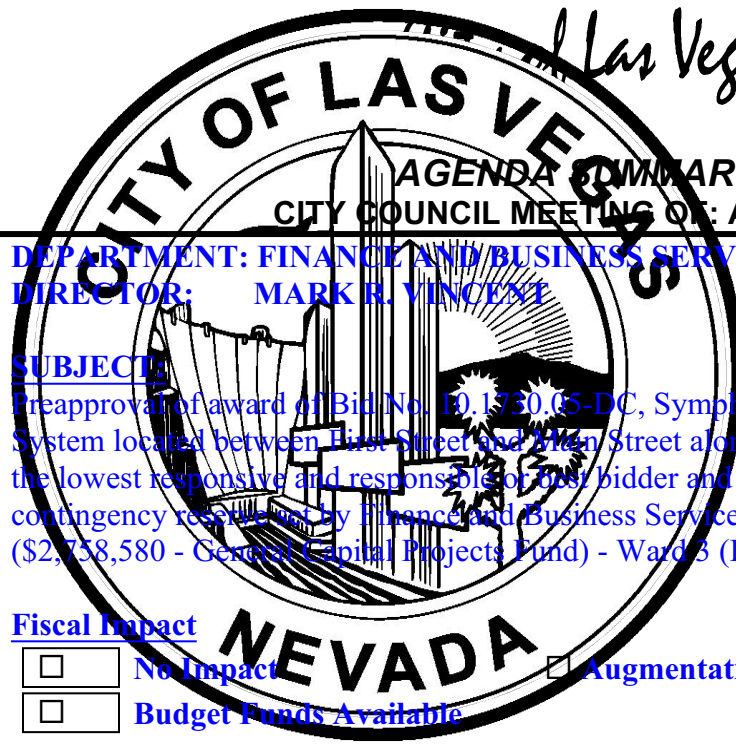

PURPOSE/BACKGROUND:

This project consists of multiple utility conduits in order to provide for future electrical service needs. Major items of work include but are not limited to: 6-inch conduit in a variety of installation scenarios, utility trenching, concrete encasement of conduits, removal and patching of asphaltic concrete paving, RS-94 manholes, jacking and boring of 36-inch steel casings, concrete sidewalk and traffic striping. Other significant efforts include utility coordination, testing, inspection, dewatering and sawcutting.
