PURPOSE/BACKGROUND:

The Southern Nevada Regional Housing Authority was created by AB478 in the 2009 Legislative session. Additionally, R-15-2009 was adopted by the Las Vegas City Council and the City of North Las Vegas; the City of Henderson; and Clark County are required to adopt similar resolutions. This board consists of 9 Commissioners; two appointed from each governing body and one Tenant Commissioner appointed by each of the governing bodies on a rotating basis. The first terms of office are staggered with 1, 2, 3 and 4 year terms, determined by lot and thereafter will be for 4 years. The Tenant Commissioner must be a current recipient of assistance from the Authority. The relevant local governments shall seek recommendations for appointment from a diverse background of interests with a view toward: balancing gender and ethnicity; and soliciting appointees who have experience in fields such as, without limitation: Real estate; Financial planning; Legal aid; Education; Public safety, the provisions of public services; and the assistance of persons of low income.

RECOMMENDATION:

Procedure for this board requires appointment by the City Council. Any member of the City Council can make a recommendation.

Minutes:

MAYOR GOODMAN thanked everyone who had expressed an interest in these positions and nominated BRENDA WILLIAMS and FATHER DAVE CASALEGGIO to serve on the Southern Nevada Regional Housing Authority Board (SNRHA).
