Dear City Council:

I would like to formally register my protest in regards to the un-permitted garage structure that was erected at 3018 Ashby Avenue, Las Vegas, NV 89102. I am a 7 year resident of McNeil Estates and do not think that the structure is compatible with the architecture of the neighborhood. Furthermore, the owner of the property, Henry Sanchez built the property without seeking the required building permits. I am told he continues to work on finishing the structure despite the denial of his variance request by the City Planning Commission. The structure is of a metal nature and belongs in an industrial park, not a historic neighborhood.

Furthermore, as Mr. Sanchez states that he has been a builder as a profession, there is no excuse for his skirting around the rules, building the structure and then trying to get approval after the fact. It demonstrates a reckless disregard for laws and lack of consideration for his neighbors.

With all the transitions that McNeil is currently facing due to the property values, abandoned, burned and half built houses, vacation rentals and half-way houses we cannot have neighbors further decreasing our property values with incompatible structures that do not meet building code requirements. Allowing this structure to remain, would be rewarding bad behavior.

Please deny his appeal for the variance request.

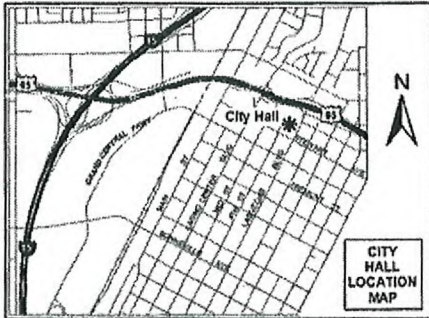
