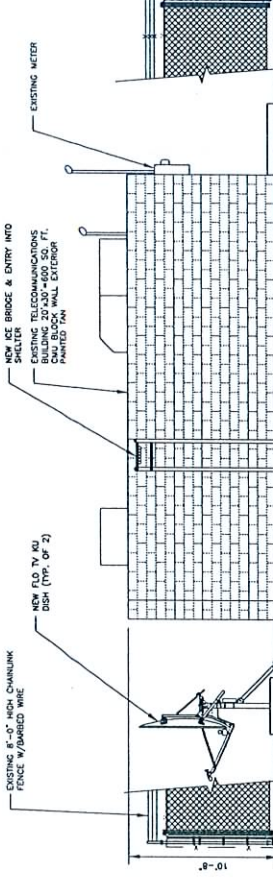
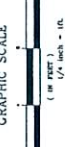
WEST ELEVATION

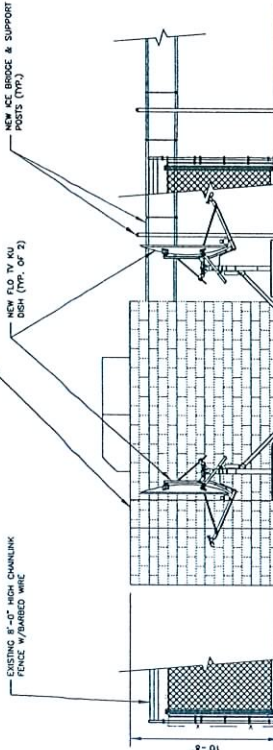
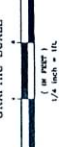
NORTH ELEVATION

GRAPHIC SCALE



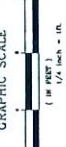
EAST ELEVATION
