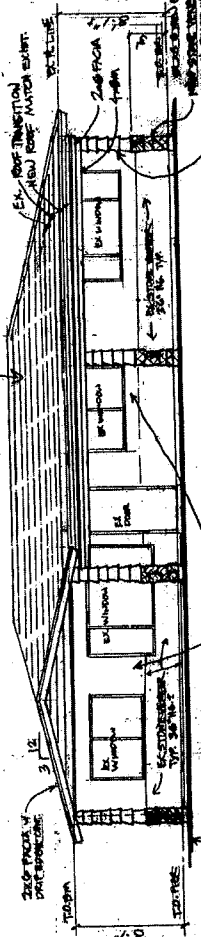
ROOF PLAN



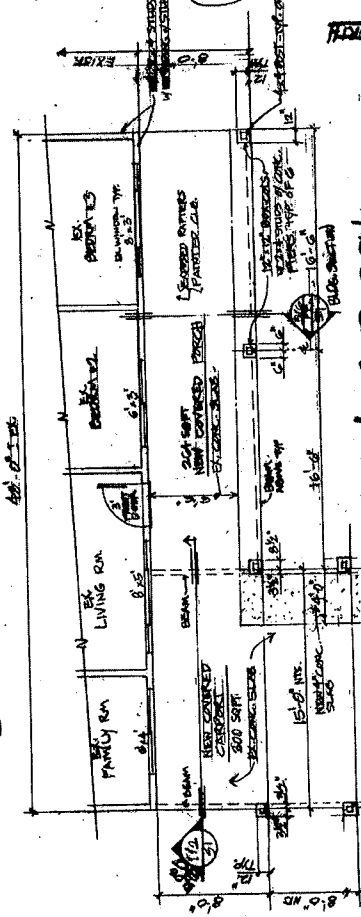
LEFT SIDE ELEVATION



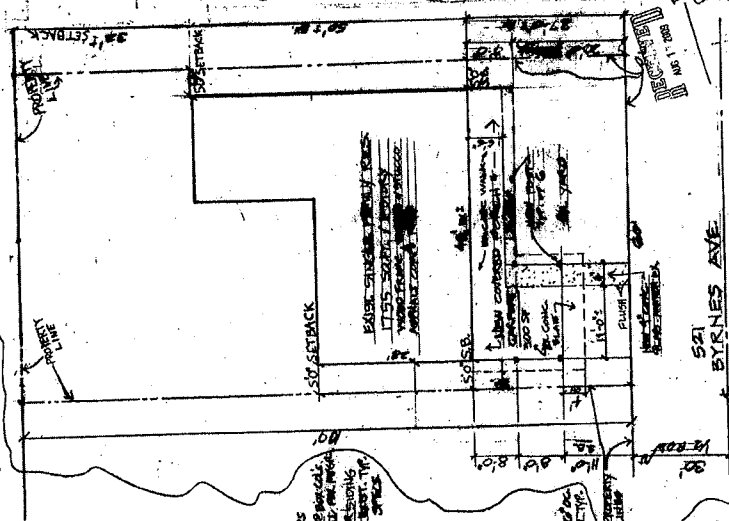
RIGHT SIDE ELEVATION



FRONT ELEVATION



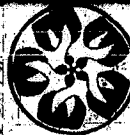
FLOOR PLAN
