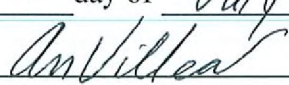

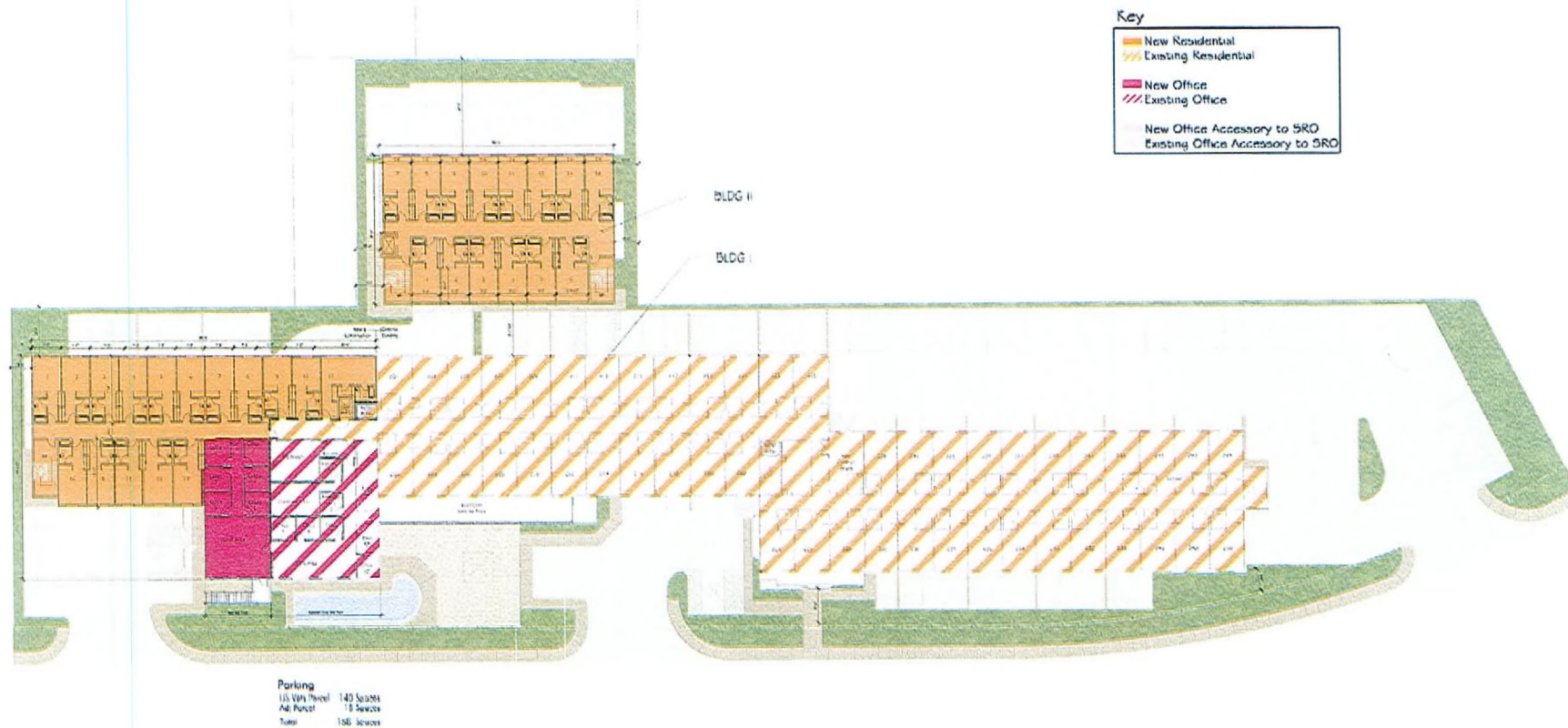

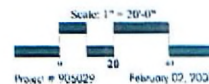
Conceptual 2nd Floor Plan

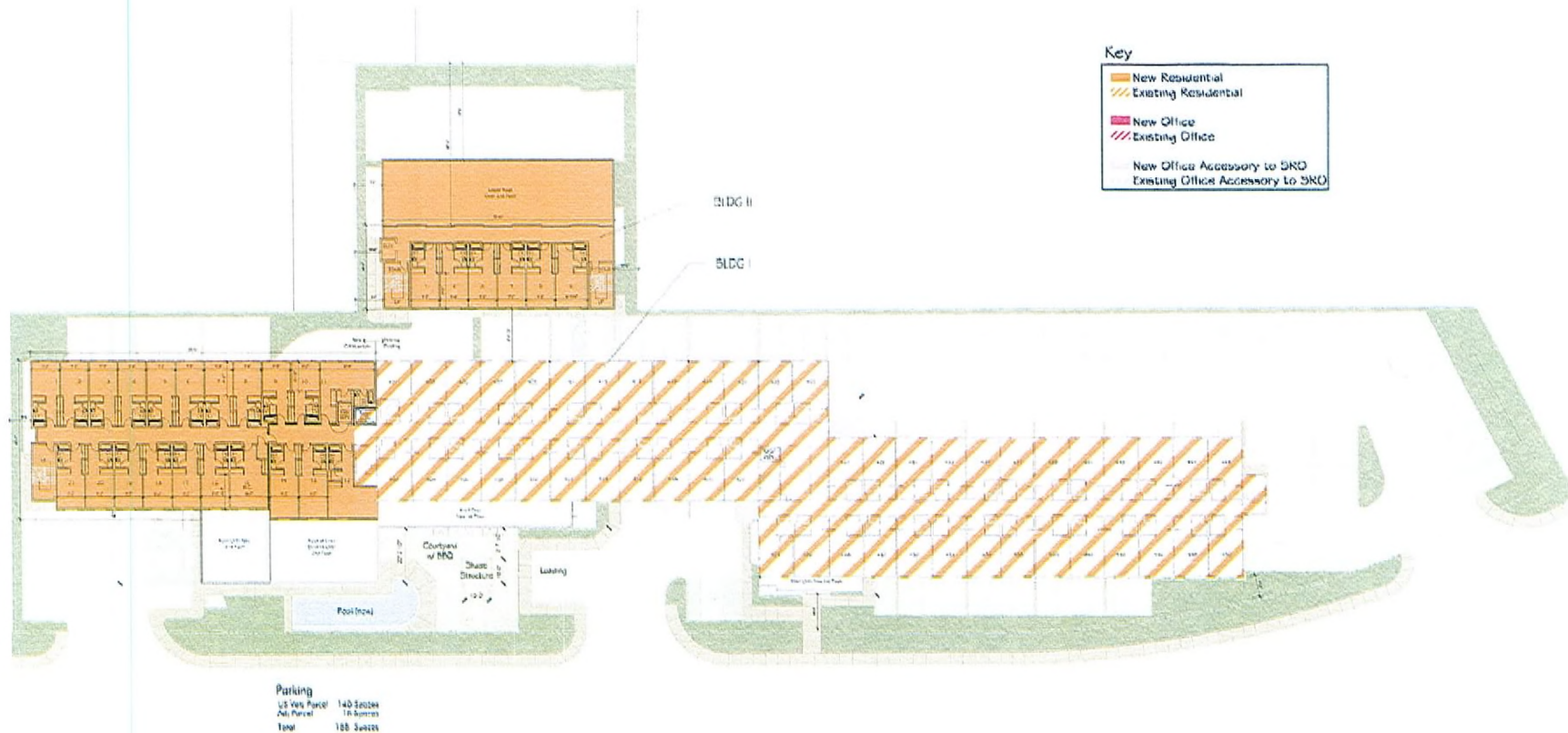

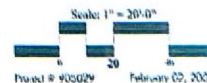


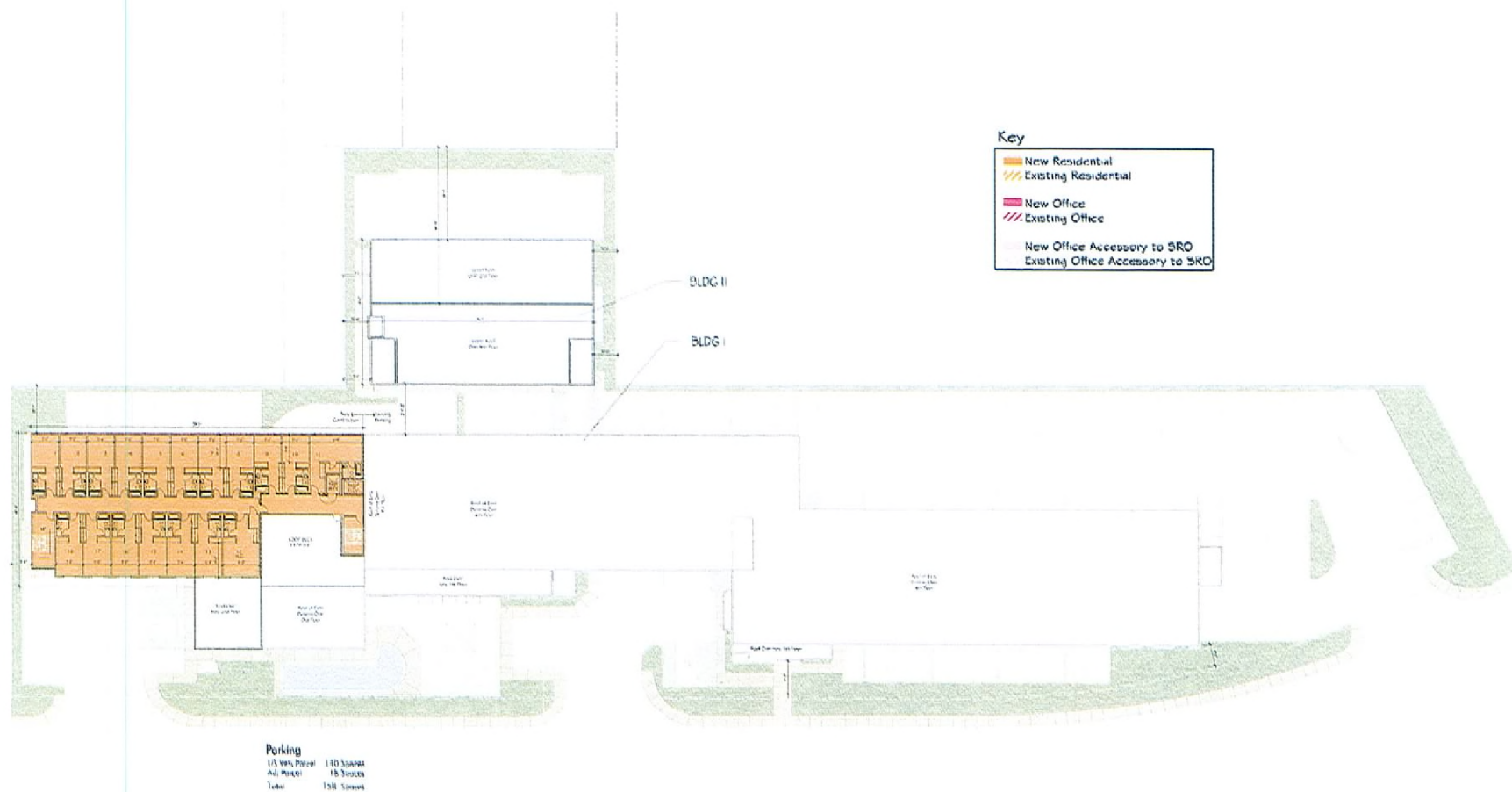


Conceptual 4th Floor Plan

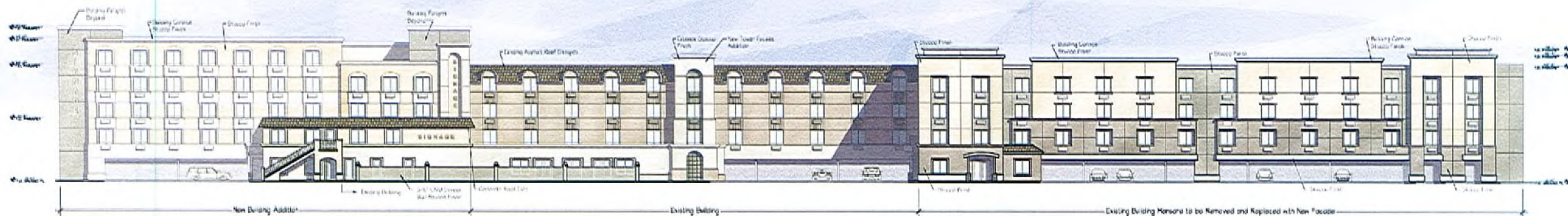


Conceptual 5th Floor Plan

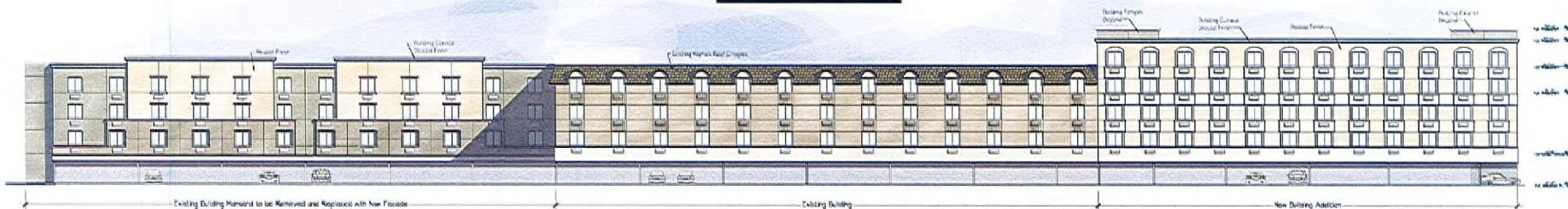

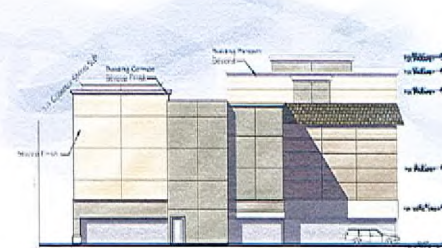
South Elevation
