PURPOSE/BACKGROUND:

The City of Las Vegas acting as fiscal agent for a formulaic four-year stimulus grant for a total of \$7,558,206 to fund justice related programs. Of the funds allocated by the Department of Justice, the City of North Las Vegas will receive \$1,139,638; the City of Henderson will receive \$502,113; the City of Mesquite will receive \$321,949.70; and Clark County will receive \$1,220,938.85. The remaining funds are allocated to the City of Las Vegas at \$4,373,566.44, of which \$2,973,566.44 directly fund City of Las Vegas programs and \$1,400,000 are allocated to Las Vegas Metropolitan Police Department as a sub-grantee of the City of Las Vegas.

The interlocal agreement defines the roles and responsibilities of each party, including reporting requirements that meet the American Recovery & Reinvestment Act Standards.
