PURPOSE/BACKGROUND:

The City of Las Vegas is the fiscal agent and will receive \$4,373,566.44 of these funds, \$2,973,566.44 of which are awarded directly to the City of Las Vegas and \$1,400,000 that will be awarded to the Las Vegas Metropolitan Police Department as a sub-grantee of the City of Las Vegas. The remaining grant funds awarded by the Department of Justice will be allocated as follows: \$1,139,638 to the City of North Las Vegas; \$502,113 to the City of Henderson; \$321,949.70 to the City of Mesquite; and \$1,220,938.85 to Clark County.

The interlocal agreement defines the roles and responsibilities of each party, including reporting requirements that meet the American Recovery & Reinvestment Act Standards.
