City Parkway IV A, Inc., and Office District Parking I, Inc., have been parties to an agreement with LiveWork Las Vegas and Forest City for Parcels P and Q in Symphony Park. Office District Parking I, Inc., owns a small sliver of land (5,258 square feet) on Parcel P. It is the desire of all parties to quitclaim deed the 5,258 square feet of Parcel P to City Parkway IV A, Inc., and remove Office District Parking I, Inc., from the real estate transaction with LiveWork Las Vegas and Forest City.
