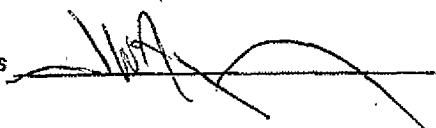
"Crazy" Street people stand at the phone and yell obscenities at it (w/ the handset & w/o the handset) in their hand.
