Dear Mr. Bilyeu:

Your request for a Variance TO ALLOW A 10-FOOT TALL WALL WHERE EIGHT FEET IS THE MAXIMUM HEIGHT ALLOWED ALONG PORTION OF THE NORTH AND EAST PROPERTY LINE AND TO ALLOW UNFINISHED BLOCK WHERE DECORATIVE BLOCK WITH 20' CONTRASTING MATERIALS IS REQUIRED; AND TO INCLUDE THE ADDITION OF AN EIGHT-FOOT HIGH WROUGHT IRON FENCE ALONG THE SOUTH PERIMETER WHERE FIVE FEET IS THE MAXIMUM ALLOWED on 20.53 acres at 1726 West Bonanza Road (APN 139-28-302-034 R-E (Residence Estates) Zone and R-3 (Medium Density Residential) Zone under Resolution of Intent to C-2 (General Commercial), Ward 5 (Barlow), was considered by the Planning Commission on April 23, 2009.

The Planning Commission voted to *APPROVE* your request, subject to the following:

Planning and Development

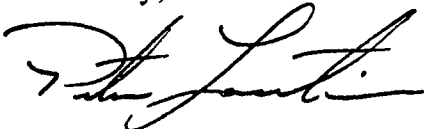
1. Conformance to the Conditions of Approval for Site Development Plan Review (SDR-22206) shall be required, if approved.
2. This approval shall be void two years from the date of final approval unless a certificate of occupancy has been issued or upon approval of final inspection. An Extension of Time may be filed for consideration to the City of Las Vegas.
