Minutes:

MAYOR PRO TEM REESE declared the Public Hearing open for Items 73 and 74. By way of reading Items 75 and 76, the Public Hearing was considered open and closed by MAYOR PRO TEM REESE for Items 75 and 76.

BOB FEIBLEMAN, 295 East Warm Springs Road, appearing on behalf of the applicant, thanked staff for their recommendations and asked for the Council's approval.

COUNCILMAN WOLFSON asked the applicant to provide a brief overview of the project. Referring to the site plan, MR. FEIBLEMAN indicated the location of the senior citizen apartment development, acknowledging COUNCILMAN WOLFSON'S statements that this expansion will provide additional amenities to the current residents.

MAYOR PRO TEM REESE declared the Public Hearing closed for Items 73 and 74.
