MAYOR PRO TEM REESE declared the Public Hearing open for Items 77 and 78.

ARTHUR NAVE, Project Manager for Auto Zone, 123 South Front Street, Memphis, Tennessee, concurred with all conditions and asked for approval.

CITY COUNCIL MEETING OF: OCTOBER 21, 2009

TODD FARLOW commented on previous discussion and using replacement of windshield wipers as an example, MR. FARLOW stated that these are the types of repairs that should be considered as minor auto repair.

COUNCILMAN BARLOW stated that he did not have the opportunity to meet with the applicant; however, in reviewing the backup documentation, he did not have any concerns regarding the proposed expansion.

When asked to address the landscaping, MR. NAVE replied that the proposal includes a landscaping plan that indicates trees on the perimeter of the lot. He stated that the existing landscape at the front of the property would be improved.

MARGO WHEELER, Director of Planning and Development, explained that the backup shows the required number of trees in the parking lot and along the buffer areas of the property. She noted that the total number of trees required is 44 but the applicant will be providing 60 trees as indicated on the site plan.

MAYOR PRO TEM WHESE declared the Public Hearing closed on Items 77 and 78.
