MAYOR PRO TEM REESE declared the Public Hearing open.

ATTORNEY MATTHEW DUSHOFF, 3320 West Sahara Avenue, introduced DAVID TRONE, owner of Total Wine and More. ATTORNEY DUSHOFF explained that Total Wine is the top private retailer of wine in the country operating over 63 retail stores throughout the United

States. In addition to offering wine training for their employees and wine tasting classes to the public, most notably, Total Wine and More has over the past two years, contributed over \$1.2 million to charities, a custom they have initiated with every grand opening.

COUNCILMAN WOLFSON invited JAMES GRINDSTAFF, 9440 West Sahara Avenue, to speak on significant changes to the Boca Fashion Village with regard to tenants. MR. GRINDSTAFF explained that Boca Park did lose several of its larger tenants but currently the existing businesses have stabilized. He welcomed Total Wine, acknowledging their commitment to the community and their financial stability.
