26. Please define "Dewatering Wells" How many are located in Clark County?
What is the general location of the abandoned well?
38. Please vote No. To our knowledge, City of Las Vegas taxpayers are the only stakeholders comprising "the City of Las Vegas, Nevada, a political subdivision of the State of Nevada. . . ." so we ask, "Are you elected CLV representatives agreeing to have a build/not build this proposed Performing Arts Center question on a ballot for our vote? Please clarify if our 'only stakeholders' determination is in error.
