The Complaint for Disciplinary Action by the DEPARTMENT OF FINANCE AND
BUSINESS SERVICES on behalf of the CITY OF LAS VEGAS, NEVADA, against you
dated October 13, 2009, a copy of which is attached to this Order and Notice, having come
before the City Council of the City of Las Vegas, Nevada, at its regular meeting held on
October 21, 2009, and the Council being satisfied that probable grounds exist for disciplinary
action against you as alleged in the Complaint for Disciplinary Action;

IT IS ORDERED that the issuance of the Complaint for Disciplinary Action and a
hearing on the Complaint for Disciplinary Action are approved.

YOU ARE HEREBY NOTIFIED that the hearing will be held before the City Council

1 Las Vegas, Nevada, 89101, on December 2, 2009, beginning at the hour of 9 a.m., or as soon
2 thereafter as the matter can be heard.

3 The hearing will be upon the charges in the Complaint for Disciplinary Action which
4 has been served upon you. You may be present at the hearing and you may be represented by
5 a lawyer. You may present any relevant evidence you have, and you will be given full
6 opportunity to cross examine all witnesses testifying against you.

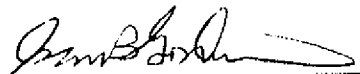
7 YOU ARE FURTHER NOTIFIED that within twenty (20) days after service of the
8 Complaint for Disciplinary Action, but not later than five (5) days before the hearing date, you
9 must file with the City Clerk, First Floor, City Hall, 400 Stewart Avenue, Las Vegas,

11 in the Complaint for Disciplinary Action, and set forth any affirmative defenses you intend to
12 raise.

13 YOU ARE ALSO NOTIFIED that your failure to file an answer to the Complaint for
14 Disciplinary Action or to appear at the hearing shall constitute an admission to all the matters
15 contained in the Complaint for Disciplinary Action as provided by Las Vegas Municipal Code
16 § 6.88.100.

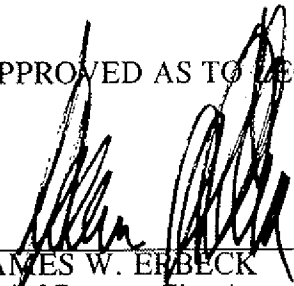

**COMPLAINT FOR
DISCIPLINARY ACTION**

17 The DEPARTMENT OF FINANCE AND BUSINESS SERVICES, on behalf of the
18 CITY OF LAS VEGAS, NEVADA (Department), Petitioner, brings this Complaint for
19 Disciplinary Action against, ADMISTCA, INC., a Nevada corporation; WILLIAM L.
20 JACOBS and ADELA JACOBS, individuals and officers of ADMISTCA, INC., 530 South
21 Martin Luther King Boulevard, Las Vegas, Clark County, Nevada, Respondents, and states:

22 Respondents WILLIAM L. JACOBS, ADELA JACOBS and ADMISTCA, INC., d/b/a
23 PARADISE LOUNGE, hold a privileged conditional Tavern License No. L16-00298-4-001445, a
24 privileged conditional Gaming License No. G01-02343-4-001445; a general Miscellaneous Sales
25 License No. M06-00667-4-001445; a general Coin Amusement Machine License No.
26 C08-01170-2-001445; a general Retail Tobacco License No. C05-02395-E-001445; and a general
27 Handbill License No. H02-01565-E-001445.

1 On December 19, 2008 at 0424 hrs. (L.V.M.P.D. Event # 081219-000512), Metro
2 responded to a report of an assault/battery at Paradise Lounge where the assailant struck the
3 victim in the face. A citation was issued to the female subject.

4 On April 25, 2009 (L.V.M.P.D. Event # 090425-000863), a car jacking occurred in
5 the parking lot of Paradise Lounge. Said event was included in the Bolden Area Command's
6 Weekly Robbery Report for the period of 04/13/09 - 04/26/09.

7 On April 26, 2009 (L.V.M.P.D. Event # 090426-000656), Metro responded to an
8 assault/battery with a firearm at Paradise Lounge. The victim refused to sign the complaint.

9 Also, on April 26, 2009, at 0515 hrs. (L.V.M.P.D. Event # 090426-000869), Metro
10 responded to Paradise Lounge where they observed Paradise Lounge security arguing with a
11 male subject who was refusing to leave the business. The male subject identified himself to
12 Metro who determined that he had an outstanding warrant for contempt of court. The male
13 subject was arrested by Metro. This incident occurred at 5:15 a.m. on a Sunday morning
14 which is contrary to the permitted hours of operation to which Jacobs agreed in the meeting of
15 February 11, 2009.

16 On May 6, 2009 at 0330 hrs. (L.V.M.P.D. Event # 090506-000393), Metro responded
17 to a fight call at Paradise Lounge. There it was reported that a fight occurred between a
18 female and a male subject who were boyfriend and girlfriend. Both were arrested for
19 participation in the fracas. This incident occurred at 3:30 a.m. on a Wednesday morning
20 which is contrary to the hours of operation to which Jacobs agreed in the meeting of
21 February 11, 2009.

22 On May 9, 2009 at 2319 hrs. (L.V.M.P.D. Event # 090509-004174), Metro officers
23 conducted a bar/perimeter check at Paradise Lounge in response to information that known
24 gang members were loitering on the premises with weapons. One male subject was arrested at
25 gunpoint after he attempted to draw a knife as they approached him. There were three other
26 individuals with him, and at least two of them have known or suspected gang affiliations.

27 On July 3, 2009 at 0254 hrs. (L.V.M.P.D. Event # 090703-000433), Metro officers
28 observed suspicious behavior by a person outside Paradise Lounge. In the course of

1 investigating, they found two cars in the alley behind the club, each with four ex-felons with
2 gang ties inside. One subject attempted to flee on foot and was caught and arrested. Search
3 warrants were served on both vehicles, and two firearms were recovered, one stolen. In all,
4 two subjects were arrested for Prohibited Person in Possession of a Firearm and three more
5 were arrested for Prohibited Person in Possession of a Firearm and for Possession of a Stolen
6 Firearm. The subject who attempted to flee was later determined to be wanted for Kidnaping
7 and Sexual Assault of a Minor.

8 On July 11, 2009 at 0418 hrs. (L.V.M.P.D. Event # 090711-000714), Metro
9 responded to a call of shots fired in the parking lot of Paradise Lounge. According to the
10 owner, William Jacobs, a regular patron of the club had been ejected for causing a disturbance
11 inside the club. The patron returned approximately thirty minutes later, approached the
12 entrance, produced a handgun and fired 15 rounds into a car parked near the entrance and into
13 the surrounding area and buildings. He then fled before LVMPD arrived. The owner
14 reported he had been returning to the club after patrolling the parking area and that the patron
15 was shooting at him. His security officers' statements conflicted with this, saying that they
16 were standing by the entrance with Jacobs when the shooting started and that, had he been
17 where he claimed, he would probably have been shot.

18 **B. CODE COMPLIANCE FAILURE**

19 On January 28, 2009 at 0900 hrs., after Paradise Lounge received its permanent license
20 subject to security review by the Director, a meeting was held at the Business Services offices,
21 400 Stewart Avenue, Third Floor, concerning the business' security employees (Vance Kevin
22 McCoy, Larry T. Banks, and Jeffrey Demetrius Walker) due to the shooting incident that
23 occurred on December 5, 2008 at 0118 hours (Event # 081205-0230). Present at the meeting
24 were: Business Services Manager Jim DiFiore, Business Licensing Supervisor Victoria
25 Rosemore, License Officer Kelly Oliverius, owner William Jacobs, and the attorney
26 representing Mr. Jacobs, Cory M. Jones, Esq. Mr. DiFiore informed Mr. Jacobs that Vance
27 Kevin McCoy has a criminal history and is not suitable as a security employee. Mr. Jacobs
28 and his attorney stated this employee would be terminated. Mr. DiFiore recommended that all

1 security employees obtain work cards. Mr. Jones concurred. Mr. Jones stated they would
2 develop policies and procedures for liability purposes. Mr. Jacobs stated he would hire a
3 female security employee to 'pat down' female patrons. Mr. Jacobs stated a dress code is
4 enforced and his operating hours have been reduced to closing at 2 a.m. on Sun./Mon./Wed.
5 and 4 or 5 a.m. on the other nights in an effort to control activities at the business. Mr.
6 Jacobs also stated he just hired a temporary security employee named Dave (last name not
7 known). Mr. DiFiore instructed Mr. Jacobs to report all Metro incidents that occur to the
8 Business License Services office by the next business day. Owner Jacobs was advised he and
9 his staff should be cooperating with Metro investigations and that security employees onsite
10 should identify themselves to Metro when they are present (security did not identify themselves
11 or volunteer to provide witness statements during the event on December 5th). Mr. DiFiore
12 concluded the meeting by advising a further meeting be scheduled with Metro Bolden Area
13 Command and the Paradise Lounge security employees so that communication can improve
14 and training with assistance for any future problems can be given.

15 Further, on February 11, 2009, at a meeting with Business Services Division Manager
16 Jim DiFiore, Business Licensing Supervisor Victoria Rosemore, License Officer Kelly
17 Oliverius, L.V.M.P.D. Bolden Area Command Sgt. Jack Clements and Officers Paul Lewis
18 and Jason Henson, the licensee/owner William Jacobs and four of his security employees
19 discussed the growing problem of criminal activity in and around the Paradise Lounge.
20 Specific attention was given to the issue of gang-related activity. Jacobs stated that he was
21 making changes to his business practices, including limiting entry to persons 25 and over,
22 enforcing a dress code, making sure the establishment is not over its occupant load, no
23 package liquor sales, security patrols in the parking area every 30 minutes and cutting off
24 beverage service at 5 a.m. He requested that Metro drive through at approximately 3 a.m. on
25 his busy nights, Tuesday, Thursday, Friday and Saturday. He added that his security
26 employees now wear uniforms and have work cards, that they are enforcing a no reentry
27 policy from 10 p.m. to 6 a.m., and that the business now closes at 3 a.m. on Sunday, Monday
28 and Wednesday. He also stated that he plans to install eight more security cameras in the alley

1 and that he was still pursuing hiring a female security guard to conduct weapons searches on
2 female customers. Business Services Enforcement staff recommended to William Jacobs that
3 he report any and all incidents at the bar to Business Services, adding that, if there was one
4 more incident, he would be required to report all personal citations and arrests.

5 On May 11, 2009, Business Services Enforcement staff conducted a compliance check.
6 The bartender, who was the only employee on duty at the time, did not have a work card in
7 her possession. A Notice of Violation was issued and for failing to maintain an up-to-date
8 employee list, and alcohol sales were suspended until a qualified bartender with the required
9 cards arrived. Also observed was advertising for "Local Hip Hop" which is contrary to what
10 owner Jacobs stated to Council on November 19, 2008, on the type of venue he would conduct
11 at Paradise Lounge. Subsequently, Mr. Jacobs was issued a citation for violation of Las Vegas
12 Municipal Code (LVMC) 6.86.030 Failure to Require Employee Work Card and 6.86.180(A)
13 Failure to Maintain and Make Available Employee List.

14 On May 19, 2009 (L.V.M.P.D. Event # 090519-004036), during a compliance check
15 by Metro, owner William Jacobs was arrested at Paradise Lounge when routine records check
16 revealed two outstanding bench warrants on traffic offenses. Also on this date a citation was
17 issued by Metro Special Investigations Section Detectives to William Jacobs for failure to have
18 an employee register a work card change of employment as required by LVMC 6.86.030.

19 On May 23, 2009 0130 hrs. (L.V.M.P.D. Event # 090523-000281), Metro officers
20 responded to Paradise Lounge for activity included overcrowding of the interior of the
21 business. Fire Marshals were called out to address the vehicles parked in the fire lanes and the
22 occupancy load being exceeded. There were 30-40 people waiting in line to get inside the
23 business and approximately 5-6 people were arrested from the parking lot. The officers onsite
24 intercepted a handbill advertising parties scheduled for May 30th and June 6th at the business.
25 These events were advertised as being promoted by Betters Entertainment, an unlicensed
26 promoter in the City of Las Vegas.

1 On May 25, 2009 0300 hrs. (L.V.M.P.D. Event # 090525-000397), Metro officers
2 issued a citation to owner William Jacobs for failure to maintain an employee list as required
3 under LVMC 6.86.180.

4 May 26, 2009, License Officer Kelly Oliverius met with Mr. Jacobs at Paradise
5 Lounge to discuss a handbill being distributed and the events that were apparently scheduled.
6 Mr. Jacobs confirmed they were using Betters Entertainment as a promoter. He was advised
7 that this promoter was not licensed with the City as required by code. When asked about
8 whether the DJ's being used were licensed he stated that he did not know. He stated one DJ
9 was an employee. He was advised that the employee should be noted on the employee list
10 required to be maintained and the others would be required to be licensed by the City.

11 Owner William Jacobs was additionally advised that the distribution of handbills
12 required a business license from the City. Mr. Jacobs was issued a Notice of Violation for
13 violation of LVMC 6.02.060(A), (B) and 6.02.320(A).

14 **SUBSTANTIVE LAW**

15 LVMC 6.02.330(H) provides [Unlawful Business Activity]:

16 The licensee may be subject to disciplinary action by the
17 City Council for good cause, which may, without limitation,
18 include:

19 . . .

20 (A) The licensee or any of its principals is engaged, or has
21 commenced, instituted, advertised, aided, carried on, continued or
22 engaged, in a business, trade or profession without having obtained
23 a valid license, an approval for suitability, a permit or a work card
24 when such a person knew that one was required or under such
25 circumstances that they reasonably should have known one was
26 required, or has solicited, encouraged, caused or procured another
27 to do so;

28

(D) The licensee or any of its principals, or their employees
or those acting on their behalf, violate a condition which is imposed
upon the license;

. . . .

(G) The premises on which the business is conducted do not
satisfy local, state or federal law or regulations which pertain to the
activity which is actually engaged in;

. . . .

1 (H) The business activity constitutes, promotes, causes,
2 allows, fosters, aids, or otherwise enables a **private nuisance,**
3 **public nuisance or chronic nuisance,** or has been or is being
4 conducted in an unlawful, illegal or impermissible manner, including
5 but not limited to causing, **allowing, promoting, fostering, aiding,**
6 **enabling, exercising deliberate ignorance towards or failing to**
7 **abate a private nuisance, public nuisance or chronic nuisance;**
8 or

9 (I) The licensee, any of its principals, their employees or
10 those acting on their behalf **failed to cooperate with the**
11 **Director's efforts to enforce the provisions of this Code.**

12 LVMC 6.02.350 provides [Acts and Omissions]:

13 A licensee under this Chapter shall be subject to
14 **disciplinary action** not only for acts or omissions done by such
15 licensee but also for acts and omissions done by the principals,
16 managers, agents, representatives, servants or employees of such
17 licensee. [Emphasis added.]

18 LVMC 6.86.030 provides [Employer responsibility, Valid Work Card]:

19 It is unlawful for any employer to employ a person who is required
20 to have a work card **unless such person has a valid work card** for
21 such employment.

22 LVMC 6.86.030 provides [Notification of changes to Work Card]:

23 **The work card holder shall notify Metro within five days of**
24 **any changes in employment, name change, or change in**
25 **residence.** This requirement is in addition to the notification
26 provision for the employer contained in Section 6.86.030.
27 [Emphasis added.]

28 STANDARD OF EVIDENCE

LVMC 6.88.090 provides:

(A) The hearing need not be conducted according to
technical rules relating to evidence and witnesses. Any
relevant evidence may be admitted.

(B) The respondent shall have the right to call and
examine witnesses on his own behalf, cross-examine opposing
witnesses, introduce exhibits and evidence relevant to the issues
of the case, and offer rebuttal evidence.

(C) The respondent may be called and examined by the
City.

(D) The Clerk shall have the power to issue subpoenas for
witnesses to appear to give testimony. [Emphasis added.]

1 PENALTY

2 LVMC 6.02.360 provides:

3 Upon a showing of good cause and in the discretion of the
4 City Council, disciplinary action against a holder may take the
5 form of cancellation, **revocation**, refusal to renew, **suspension**,
6 imposition of conditions or **restrictions** or civil **fine** in an amount
7 not to exceed one thousand dollars for each day that the violation
8 which forms the subject matter of the complaint that recommends
9 such disciplinary action is demonstrated to have been in
10 existence, or any combination of such actions, as the particular
11 situation may require. **The Council may also impose against the**
12 **licensee the actual costs incurred, and a reasonable amount**
13 **for attorney's fees**, resulting from the imposition of disciplinary
14 action. The disciplinary actions available in this Section shall be
15 in addition to, and not exclusive of, any other civil or criminal
16 remedy which otherwise might be available. [Emphasis added.]

11 ALLEGATIONS

12 COUNT ONE

13 It is alleged that between November 19, 2008 and present, Respondents William L.
14 Jacobs, Adela Jacobs and Admistca, Inc., d/b/a Paradise Lounge, operated a business which
15 constituted a public, private and chronic nuisance and which has been conducted in an
16 unlawful, illegal and impermissible manner, to wit: creating, promoting, fostering, aiding,
17 enabling, exercising deliberate ignorance towards or failing to abate a private nuisance, public
18 nuisance or chronic nuisance and permitting an environment in which violence occurred, to
19 include Possession of Stolen Firearm, Prohibited Person in Possession of a Firearm, Battery,
20 Assault With a Deadly Weapon, Violence and Malicious Destruction of Private Property, all
21 of which required a disproportionate use of Las Vegas Metropolitan Police Department
22 resources in violation of the Las Vegas Municipal Code and the Nevada Revised Statutes.

23 COUNT TWO

24 It is alleged that between November 19, 2008 and present, Respondents William L.
25 Jacobs, Adela Jacobs and Admistca, Inc., d/b/a Paradise Lounge, operated a business which they
26 and its principals, employees and others acting on its behalf failed to require of its employees
27 and others related directly and indirectly to the business to acquire, maintain and report work
28 cards, change of employment registration and other required documents and failing to

1 cooperate with the Director of Business Services efforts to enforce the provisions of the Las
2 Vegas Municipal Code, in violation of the Las Vegas Municipal Code and the Nevada Revised
3 Statutes.

4 **WHEREFORE**, the Petitioner respectfully requests the City Council to:

5 A. Approve the Complaint for Disciplinary Action and order a disciplinary hearing
6 at which the Respondent shall appear and show cause why the licenses that are the subject of
7 this Complaint should not be suspended or revoked, or other disciplinary action taken; or

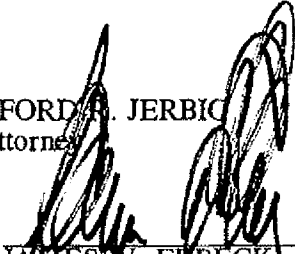
8 B. Grant such other and further relief as the Council deems appropriate.

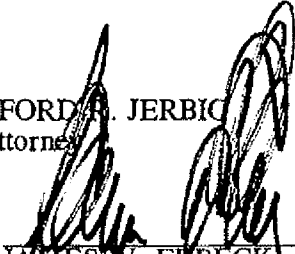

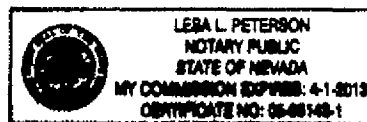

Paradise Lounge, 530 South Martin Luther King Boulevard, Las Vegas, NV 89106 was previously granted the following City of Las Vegas licenses: privileged conditional Tavern License No. L16-00298-4-001445, privileged conditional Gaming License No. G01-02343-4-001445; general Miscellaneous Sales License No. M06-00667-4-001445; general Coin Amusement Machine License No. C08-01170-2-001445; general Retail Tobacco License No. C05-02395-E-001445; and general Handbill License No. H02-01565-E-001445. The licenses were issued to Admistca, Inc., with yourselves listed as principals therein. Those licenses were issued and are in effect today. The purpose of this letter is to immediately suspend, under the emergency suspension provisions of Las Vegas Municipal Code 6.02.363, City Tavern License No. L16-00298-4-001445, as well as any other City business or gaming licenses having to do with the operation of your business at 530 South Martin Luther King Boulevard, Las Vegas, Nevada.

LAW

The authority for this action is to be found at Las Vegas Municipal Code 6.02.363:

(A) Except as provided in Subsection (B), and independent of any other action, the Director or Metro may issue an emergency order which suspends or conditions a license upon a determination that:

(1) There has been a violation of the provisions of this Title, Title 9 or Title 19; and

(2) Such order is necessary for the immediate preservation of the public peace, health, safety, morals, good order or general welfare within the City.

(B) This Section does not apply to any business license issued pursuant to Chapter 6.06A or Chapter 6.35.

As well as Las Vegas Municipal Code 6.02.365:

Any emergency order issued pursuant to Section 6.02.363 shall:

(A) Set forth the grounds upon which it is issued, including a statement of facts constituting the emergency which necessitates such order;

(B) Be effective immediately upon the issuance and service thereof on the licensee or its representative or upon the licensed premises; and

(C) Indicate the period of time for which it is effective, which shall be based upon the severity of the violation and the nature of the emergency as determined by the Director or Metro.

Your right of appeal is to be found at Las Vegas Municipal Code 6.02.367:

A licensee who is affected by an emergency order may appeal the order by filing an appropriate action in the State of Nevada District Court to challenge or seek review of the order. Such action to appeal must be filed within ten days after the effective date of the emergency order, or the right to appeal is deemed waived. Nothing in this Section shall be construed to limit any statutory right of the licensee to file an ordinary or emergency petition for extraordinary writ under NRS Chapter 34, where appeal under this Section is an inadequate remedy at law. Where the Director or Metro is alleged to have engaged in censorship of expressive conduct or material rather than addressing or avoiding criminal conduct or other conduct harmful to the public health, safety, welfare, morals and peace, prompt judicial review is warranted under *City of Littleton, Colorado v. Z.J. Gifts D-4, L.L.C.*, 541 U.S. 774, 124 S. Ct. 2219, 159 L. Ed. 2d 84 (2004).

Las Vegas Municipal Code 6.02.330(H) provides:

A licensee may be subject to disciplinary action by the City Council for good cause, which may, without limitation, include the following:

. . . .

(H) The business activity constitutes, promotes, causes, allows, fosters, aids, or otherwise enables a private nuisance, public nuisance or chronic nuisance, or has been or is being conducted in an unlawful, illegal or impermissible manner, including but not limited to causing, allowing, promoting, fostering, aiding, enabling, exercising deliberate ignorance towards or failing to abate a private nuisance, public nuisance or chronic nuisance

Las Vegas Municipal Code 6.02.350 provides:

A licensee under this Chapter shall be subject to disciplinary action not only for acts or omissions done by such licensee but also for acts and omissions done by the principals, managers, agents, representatives, servants or employees of such licensee.

Documents, and other information, in my possession reveal that the City of Las Vegas Department of Finance and Business Services and the Las Vegas Metropolitan Police Department ("L.V.M.P.D.") have found repeated violations of the Las Vegas Municipal Code in that your business has been run in a manner which constitutes, promotes, causes, allows, fosters, aids, or otherwise enables a serious threat to the public safety as a public nuisance or chronic nuisance, and has been or is being conducted in an unlawful, illegal or impermissible manner, including but not limited to causing, allowing, promoting, fostering, aiding, enabling, exercising deliberate ignorance towards or failing to abate a said private nuisance, public nuisance or chronic nuisance by creating a dangerous public and business condition to persist in your establishment and on its property wherein illegal firearms have been unlawfully possessed, mass and individual fighting has occurred, assaults and batteries have been committed, public indecency engaged in, and failure to abide and adhere to administrative code provisions for the health, safety and protection of the citizens.

GROUND FOR EMERGENCY SUSPENSION

Within the past year, or since November 19, 2008, an escalating pattern of dangerous and criminal activity including gun and physical violence has occurred, serious felonies and lesser crimes committed, public fighting and tumultuous activity in and near the business establishment at hours creating repeated disturbance to others and inordinate police investigative response necessary to protect the public. These incidents are no less than 250 in number, including in the past six (6) weeks over 73 police service calls and investigative stops. I am attaching the Disciplinary Complaint (Exhibit 1) recently filed for approval before the Las Vegas City Council which sets forth some of the more serious allegations occurring between December 5, 2008, and July 11, 2009, incorporated in its entirety in this Letter of Suspension by this reference.

In addition, most recently, the 73 police service calls and investigative stops, include:

- 1) October 3, 2009 at 0404 hrs. - 40-50 subjects fighting in the Paradise Lounge parking lot, at least one subject with firearm, gun being recovered nearby;
- 2) October 4, 2009 at 0547 hrs. - 2 subjects fighting with owner involved, one automobile used as deadly weapon to attempt to run over security person;
- 3) October 5, 2009 at 0040 hrs - subjects refused to leave premises/area and investigative stop conducted;
- 4) October 11, 2009 at 0149 hrs - person with gun in parking lot, 3 to 10 shots fired, 40-50 subjects in parking lot, another subject with gun, at Cabana Bar [adjacent business, owned by same owners] shots fired, information received regarding Uzi machine gun sighted but not recovered..

Since being licensed at Paradise Lounge, my office and the L.V.M.P.D. have met with you repeatedly in an effort to reduce the calls for police service, number of gang disturbances, instances of fighting, use and presence of weapons but you have failed to accept and follow through upon our recommendations. Despite promises by you of increased security personnel, you not only sought to employ an ex-felon in such position, but equally important a key security employee has quit your employ just recently. You have indicated to me that if any adverse impact might befall your licensed status in the City of Las Vegas, you would either "walk away" from the business or "try to sell it". I am not only greatly concerned about the lessened security in an already dangerous locale but also your patrons potentially violent reaction when they learn of the pending/filed Disciplinary Complaint before the City Council. The escalating violence in the past week and several months is an extremely dangerous situation resulting in classification of Paradise Lounge as a public and chronic nuisance dangerous to the public safety.

POST-SUSPENSION APPEAL

The law provides you the right to appeal this emergency suspension order pursuant to Las Vegas Municipal Code 6.06.290. Such action to appeal to the State of Nevada District Court to challenge or seek review of its issuance must be filed within ten (10) calendar days after the effective date of this emergency order or the right to appeal shall be deemed waived.

PERIOD OF TIME FOR WHICH THE SUSPENSION IS EFFECTIVE

You are ordered to immediately suspend all business operations at your 530 South Martin Luther King Boulevard, Las Vegas, Nevada, "Paradise Lounge" location which operations are conducted under Las Vegas City licensure. This suspension is for an indefinite period of time, or until the City Council hears a disciplinary complaint brought against your licensure.

The DEPARTMENT OF FINANCE AND BUSINESS SERVICES, on behalf of the
CITY OF LAS VEGAS, NEVADA (Department), Petitioner, brings this Complaint for
Disciplinary Action against, ADMISTCA, INC., a Nevada corporation; WILLIAM L.
JACOBS and ADELA JACOBS, individuals and officers of ADMISTCA, INC., 530 South
Martin Luther King Boulevard, Las Vegas, Clark County, Nevada, Respondents, and states:

Respondents WILLIAM L. JACOBS, ADELA JACOBS and ADMISTCA, INC., d/b/a
PARADISE LOUNGE, hold a privileged conditional Tavern License No. L16-00298-4-001445, a
privileged conditional Gaming License No. G01-02343-4-001445; a general Miscellaneous Sales
License No. M06-00667-4-001445; a general Coin Amusement Machine License No.
C08-01170-2-001445; a general Retail Tobacco License No. C05-02395-E-001445; and a general
Handbill License No. H02-01565-E-001445.

....

SUMMARY OF ALLEGATIONS

Paradise Lounge is owned by William L. Jacobs and Adela Jacobs through their respective interests in Admistca, Inc., a Nevada corporation. It has been operated repeatedly in an unlawful manner since it opened by creating a public and chronic nuisance in violation of Las Vegas municipal business licensing codes and failing to adhere to administrative mandates pertaining to work cards, time of operation, reporting and other areas.

On November 19, 2008, Respondents were originally granted a permanent tavern license subject to the condition that onsite security meet the licensing requirements of Business Services. Many meetings and discussions were held regarding security and other matters which requirements were violated.

Since its permanent licensing there has been more than 179 calls for service by Paradise Lounge to the Las Vegas Metropolitan Police Department ("L.V.M.P.D."). Only those more severe service calls directly related to the use/possession of weapons, gang activity, assault/battery and events related to failure to comply with work card and other administrative requirements are set forth below.

CALLS FOR SERVICE AND CODE COMPLIANCE FAILURE

A. CALLS FOR SERVICE

On December 5, 2008 at 0118 hrs. (L.V.M.P.D. Event # 081205-000230) Metro responded to a gang-related report of shots fired inside Paradise Lounge wherein two persons were wounded. Paradise Lounge security staff was present. A number of shots were fired in the parking lot and a gun was pointed at a security guard in the parking lot at approximately the same time the shooting took place inside or shortly thereafter.

On December 10, 2008 at 0233 hrs. (L.V.M.P.D. Event # 081210-000358) during a bar perimeter check Metro arrested a male subject who was acting as a DJ inside Paradise Lounge for a no-bail warrant out of Clark County Detention Center at 530 South Martin Luther King Boulevard, Las Vegas, Nevada.

....

....

1 On December 19, 2008 at 0424 hrs. (L.V.M.P.D. Event # 081219-000512), Metro
2 responded to a report of an assault/battery at Paradise Lounge where the assailant struck the
3 victim in the face. A citation was issued to the female subject.

4 On April 25, 2009 (L.V.M.P.D. Event # 090425-000863), a car jacking occurred in
5 the parking lot of Paradise Lounge. Said event was included in the Bolden Area Command's
6 Weekly Robbery Report for the period of 04/13/09 - 04/26/09.

7 On April 26, 2009 (L.V.M.P.D. Event # 090426-000656), Metro responded to an
8 assault/battery with a firearm at Paradise Lounge. The victim refused to sign the complaint.

9 Also, on April 26, 2009, at 0515 hrs. (L.V.M.P.D. Event # 090426-000869), Metro
10 responded to Paradise Lounge where they observed Paradise Lounge security arguing with a
11 male subject who was refusing to leave the business. The male subject identified himself to
12 Metro who determined that he had an outstanding warrant for contempt of court. The male
13 subject was arrested by Metro. This incident occurred at 5:15 a.m. on a Sunday morning
14 which is contrary to the permitted hours of operation to which Jacobs agreed in the meeting of
15 February 11, 2009.

16 On May 6, 2009 at 0330 hrs. (L.V.M.P.D. Event # 090506-000393), Metro responded
17 to a fight call at Paradise Lounge. There it was reported that a fight occurred between a
18 female and a male subject who were boyfriend and girlfriend. Both were arrested for
19 participation in the fracas. This incident occurred at 3:30 a.m. on a Wednesday morning
20 which is contrary to the hours of operation to which Jacobs agreed in the meeting of
21 February 11, 2009.

22 On May 9, 2009 at 2319 hrs. (L.V.M.P.D. Event # 090509-004174), Metro officers
23 conducted a bar/perimeter check at Paradise Lounge in response to information that known
24 gang members were loitering on the premises with weapons. One male subject was arrested at
25 gunpoint after he attempted to draw a knife as they approached him. There were three other
26 individuals with him, and at least two of them have known or suspected gang affiliations.

27 On July 3, 2009 at 0254 hrs. (L.V.M.P.D. Event # 090703-000433), Metro officers
28 observed suspicious behavior by a person outside Paradise Lounge. In the course of

1 investigating, they found two cars in the alley behind the club, each with four ex-felons with
2 gang ties inside. One subject attempted to flee on foot and was caught and arrested. Search
3 warrants were served on both vehicles, and two firearms were recovered, one stolen. In all,
4 two subjects were arrested for Prohibited Person in Possession of a Firearm and three more
5 were arrested for Prohibited Person in Possession of a Firearm and for Possession of a Stolen
6 Firearm. The subject who attempted to flee was later determined to be wanted for Kidnaping
7 and Sexual Assault of a Minor.

8 On July 11, 2009 at 0418 hrs. (L.V.M.P.D. Event # 090711-000714), Metro
9 responded to a call of shots fired in the parking lot of Paradise Lounge. According to the
10 owner, William Jacobs, a regular patron of the club had been ejected for causing a disturbance
11 inside the club. The patron returned approximately thirty minutes later, approached the
12 entrance, produced a handgun and fired 15 rounds into a car parked near the entrance and into
13 the surrounding area and buildings. He then fled before LVMPD arrived. The owner
14 reported he had been returning to the club after patrolling the parking area and that the patron
15 was shooting at him. His security officers' statements conflicted with this, saying that they
16 were standing by the entrance with Jacobs when the shooting started and that, had he been
17 where he claimed, he would probably have been shot.

18 **B. CODE COMPLIANCE FAILURE**

19 On January 28, 2009 at 0900 hrs., after Paradise Lounge received its permanent license
20 subject to security review by the Director, a meeting was held at the Business Services offices,
21 400 Stewart Avenue, Third Floor, concerning the business' security employees (Vance Kevin
22 McCoy, Larry T. Banks, and Jeffrey Demetrius Walker) due to the shooting incident that
23 occurred on December 5, 2008 at 0118 hours (Event # 081205-0230). Present at the meeting
24 were: Business Services Manager Jim DiFiore, Business Licensing Supervisor Victoria
25 Rosemore, License Officer Kelly Oliverius, owner William Jacobs, and the attorney
26 representing Mr. Jacobs, Cory M. Jones, Esq. Mr. DiFiore informed Mr. Jacobs that Vance
27 Kevin McCoy has a criminal history and is not suitable as a security employee. Mr. Jacobs
28 and his attorney stated this employee would be terminated. Mr. DiFiore recommended that all

1 security employees obtain work cards. Mr. Jones concurred. Mr. Jones stated they would
2 develop policies and procedures for liability purposes. Mr. Jacobs stated he would hire a
3 female security employee to 'pat down' female patrons. Mr. Jacobs stated a dress code is
4 enforced and his operating hours have been reduced to closing at 2 a.m. on Sun./Mon./Wed.
5 and 4 or 5 a.m. on the other nights in an effort to control activities at the business. Mr.
6 Jacobs also stated he just hired a temporary security employee named Dave (last name not
7 known). Mr. DiFiore instructed Mr. Jacobs to report all Metro incidents that occur to the
8 Business License Services office by the next business day. Owner Jacobs was advised he and
9 his staff should be cooperating with Metro investigations and that security employees onsite
10 should identify themselves to Metro when they are present (security did not identify themselves
11 or volunteer to provide witness statements during the event on December 5th). Mr. DiFiore
12 concluded the meeting by advising a further meeting be scheduled with Metro Bolden Area
13 Command and the Paradise Lounge security employees so that communication can improve
14 and training with assistance for any future problems can be given.

15 Further, on February 11, 2009, at a meeting with Business Services Division Manager
16 Jim DiFiore, Business Licensing Supervisor Victoria Rosemore, License Officer Kelly
17 Oliverius, L.V.M.P.D. Bolden Area Command Sgt. Jack Clements and Officers Paul Lewis
18 and Jason Henson, the licensee/owner William Jacobs and four of his security employees
19 discussed the growing problem of criminal activity in and around the Paradise Lounge.
20 Specific attention was given to the issue of gang-related activity. Jacobs stated that he was
21 making changes to his business practices, including limiting entry to persons 25 and over,
22 enforcing a dress code, making sure the establishment is not over its occupant load, no
23 package liquor sales, security patrols in the parking area every 30 minutes and cutting off
24 beverage service at 5 a.m. He requested that Metro drive through at approximately 3 a.m. on
25 his busy nights, Tuesday, Thursday, Friday and Saturday. He added that his security
26 employees now wear uniforms and have work cards, that they are enforcing a no reentry
27 policy from 10 p.m. to 6 a.m., and that the business now closes at 3 a.m. on Sunday, Monday
28 and Wednesday. He also stated that he plans to install eight more security cameras in the alley

1 and that he was still pursuing hiring a female security guard to conduct weapons searches on
2 female customers. Business Services Enforcement staff recommended to William Jacobs that
3 he report any and all incidents at the bar to Business Services, adding that, if there was one
4 more incident, he would be required to report all personal citations and arrests.

5 On May 11, 2009, Business Services Enforcement staff conducted a compliance check.
6 The bartender, who was the only employee on duty at the time, did not have a work card in
7 her possession. A Notice of Violation was issued and for failing to maintain an up-to-date
8 employee list, and alcohol sales were suspended until a qualified bartender with the required
9 cards arrived. Also observed was advertising for "Local Hip Hop" which is contrary to what
10 owner Jacobs stated to Council on November 19, 2008, on the type of venue he would conduct
11 at Paradise Lounge. Subsequently, Mr. Jacobs was issued a citation for violation of Las Vegas
12 Municipal Code (LVMC) 6.86.030 Failure to Require Employee Work Card and 6.86.180(A)
13 Failure to Maintain and Make Available Employee List.

14 On May 19, 2009 (L.V.M.P.D. Event # 090519-004036), during a compliance check
15 by Metro, owner William Jacobs was arrested at Paradise Lounge when routine records check
16 revealed two outstanding bench warrants on traffic offenses. Also on this date a citation was
17 issued by Metro Special Investigations Section Detectives to William Jacobs for failure to have
18 an employee register a work card change of employment as required by LVMC 6.86.030.

19 On May 23, 2009 0130 hrs. (L.V.M.P.D. Event # 090523-000281), Metro officers
20 responded to Paradise Lounge for activity included overcrowding of the interior of the
21 business. Fire Marshals were called out to address the vehicles parked in the fire lanes and the
22 occupancy load being exceeded. There were 30-40 people waiting in line to get inside the
23 business and approximately 5-6 people were arrested from the parking lot. The officers onsite
24 intercepted a handbill advertising parties scheduled for May 30th and June 6th at the business.
25 These events were advertised as being promoted by Betters Entertainment, an unlicensed
26 promoter in the City of Las Vegas.

1 On May 25, 2009 0300 hrs. (L.V.M.P.D. Event # 090525-000397), Metro officers
2 issued a citation to owner William Jacobs for failure to maintain an employee list as required
3 under LVMC 6.86.180.

4 May 26, 2009, License Officer Kelly Oliverius met with Mr. Jacobs at Paradise
5 Lounge to discuss a handbill being distributed and the events that were apparently scheduled.
6 Mr. Jacobs confirmed they were using Betters Entertainment as a promoter. He was advised
7 that this promoter was not licensed with the City as required by code. When asked about
8 whether the DJ's being used were licensed he stated that he did not know. He stated one DJ
9 was an employee. He was advised that the employee should be noted on the employee list
10 required to be maintained and the others would be required to be licensed by the City.

11 Owner William Jacobs was additionally advised that the distribution of handbills
12 required a business license from the City. Mr. Jacobs was issued a Notice of Violation for
13 violation of LVMC 6.02.060(A), (B) and 6.02.320(A).

14 **SUBSTANTIVE LAW**

15 LVMC 6.02.330(H) provides [Unlawful Business Activity]:

16 The licensee may be subject to disciplinary action by the
17 City Council for good cause, which may, without limitation,
include:

18 . . .

19 (A) The licensee or any of its principals is engaged, or has
20 commenced, instituted, advertised, aided, carried on, continued or
21 engaged, in a business, trade or profession without having obtained
22 a valid license, an approval for suitability, a permit or a **work card**
when such a person knew that one was required or under such
circumstances that they reasonably should have known one was
required, or has solicited, encouraged, caused or procured another
to do so;

24 (D) The licensee or any of its principals, or their employees
25 or those acting on their behalf, violate a condition which is imposed
upon the license;

26

27 (G) The premises on which the business is conducted do not
28 satisfy local, state or federal law or regulations which pertain to the
activity which is actually engaged in;

....

1 (H) The business activity constitutes, promotes, causes,
2 allows, fosters, aids, or otherwise enables a **private nuisance,**
3 **public nuisance or chronic nuisance,** or has been or is being
4 conducted in an unlawful, illegal or impermissible manner, including
5 but not limited to causing, **allowing, promoting, fostering, aiding,**
6 **enabling, exercising deliberate ignorance towards or failing to**
7 **abate a private nuisance, public nuisance or chronic nuisance;**
8 or

9 (I) The licensee, any of its principals, their employees or
10 those acting on their behalf **failed to cooperate with the**

12 LVMC 6.02.350 provides [Acts and Omissions]:

13 A licensee under this Chapter shall be subject to
14 **disciplinary action** not only for acts or omissions done by such
15 licensee but also for acts and omissions done by the principals,
16 managers, agents, representatives, servants or employees of such
17 licensee. [Emphasis added.]

18 LVMC 6.86.030 provides [Employer responsibility, Valid Work Card]:

19 It is unlawful for any employer to employ a person who is required
20 to have a work card **unless such person has a valid work card** for
21 such employment.

22 LVMC 6.86.030 provides [Notification of changes to Work Card]:

23 The work card holder shall notify Metro within five days of
24 any changes in employment, name change, or change in
25 residence. This requirement is in addition to the notification
26 provision for the employer contained in Section 6.86.030.
27 [Emphasis added.]

28 STANDARD OF EVIDENCE

LVMC 6.88.090 provides:

(A) The hearing need not be conducted according to
technical rules relating to evidence and witnesses. Any
relevant evidence may be admitted.

(B) The respondent shall have the right to call and
examine witnesses on his own behalf, cross-examine opposing
witnesses, introduce exhibits and evidence relevant to the issues
of the case, and offer rebuttal evidence.

(C) The respondent may be called and examined by the
City.

(D) The Clerk shall have the power to issue subpoenas for
witnesses to appear to give testimony. [Emphasis added.]

PENALTY

LVMC 6.02.360 provides:

Upon a showing of good cause and in the discretion of the City Council, disciplinary action against a holder may take the form of cancellation, **revocation**, refusal to renew, **suspension**, imposition of conditions or **restrictions** or civil **fine** in an amount not to exceed one thousand dollars for each day that the violation which forms the subject matter of the complaint that recommends such disciplinary action is demonstrated to have been in existence, or any combination of such actions, as the particular situation may require. **The Council may also impose against the licensee the actual costs incurred, and a reasonable amount for attorney's fees**, resulting from the imposition of disciplinary action. The disciplinary actions available in this Section shall be in addition to, and not exclusive of, any other civil or criminal remedy which otherwise might be available. [Emphasis added.]

ALLEGATIONS

COUNT ONE

It is alleged that between November 19, 2008 and present, Respondents William L. Jacobs, Adela Jacobs and Admistca, Inc., d/b/a Paradise Lounge, operated a business which constituted a public, private and chronic nuisance and which has been conducted in an unlawful, illegal and impermissible manner, to wit: creating, promoting, fostering, aiding, enabling, exercising deliberate ignorance towards or failing to abate a private nuisance, public nuisance or chronic nuisance and permitting an environment in which violence occurred, to include Possession of Stolen Firearm, Prohibited Person in Possession of a Firearm, Battery, Assault With a Deadly Weapon, Violence and Malicious Destruction of Private Property, all of which required a disproportionate use of Las Vegas Metropolitan Police Department resources in violation of the Las Vegas Municipal Code and the Nevada Revised Statutes.

COUNT TWO

It is alleged that between November 19, 2008 and present, Respondents William L. Jacobs, Adela Jacobs and Admistca, Inc., d/b/a Paradise Lounge, operated a business which they and its principals, employees and others acting on its behalf failed to require of its employees and others related directly and indirectly to the business to acquire, maintain and report work cards, change of employment registration and other required documents and failing to

1 cooperate with the Director of Business Services efforts to enforce the provisions of the Las
2 Vegas Municipal Code, in violation of the Las Vegas Municipal Code and the Nevada Revised
3 Statutes.

4 **WHEREFORE**, the Petitioner respectfully requests the City Council to:

5 A. Approve the Complaint for Disciplinary Action and order a disciplinary hearing
6 at which the Respondent shall appear and show cause why the licenses that are the subject of
7 this Complaint should not be suspended or revoked, or other disciplinary action taken; or

8 B. Grant such other and further relief as the Council deems appropriate.

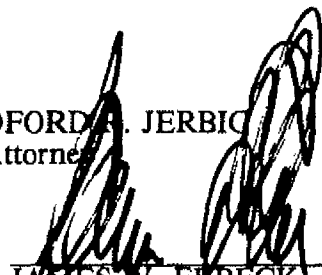

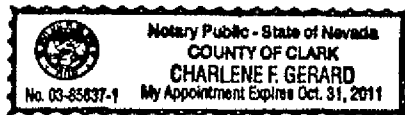

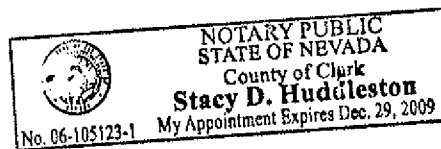
