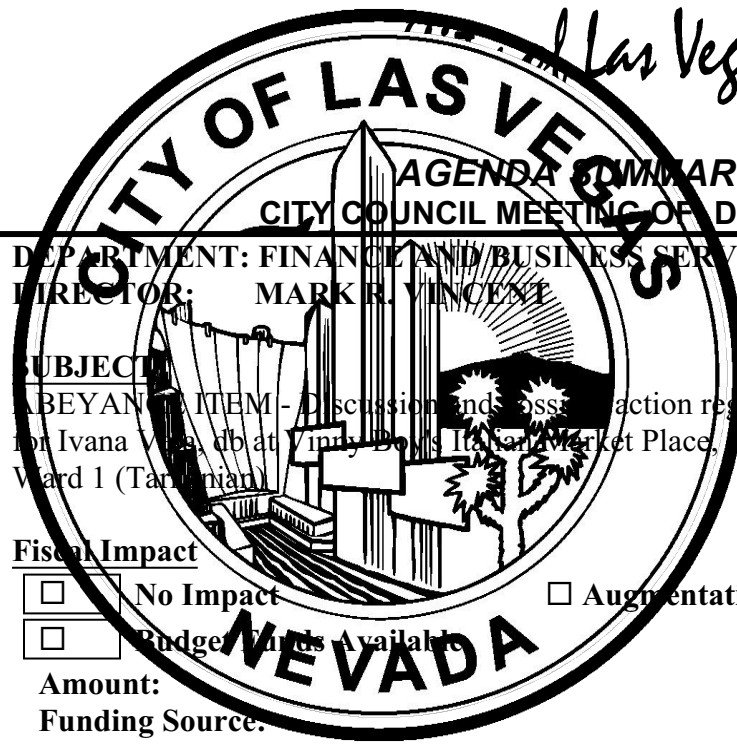

CITY COUNCIL MEETING OF: DECEMBER 2, 2009

Minutes:

JIM DiFIORE, Manager of Business Services, referred to the confidential report provided to the Councilmembers for a listing of the concerns related to the appellant, who was present. Although MS. VELA could not obtain a letter of support from her probation officer, she asked that the Council continue and consider her appeal, to which MR. DiFIORE added that MS. VELA'S probation officer indicated to him that they were having difficulties connecting.

MR. DiFIORE commented that although MS. VELA had two prior convictions, her probation officer is in support of her employment as MS. VELA is considered a low-risk client who has passed her drug tests. MS. VELA affirmed for the Mayor that she informed her employer of her history. MR. DiFIORE recommended the work card be granted with several conditions he suggested.
