17 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
18 ORDAIN AS FOLLOWS:

19 SECTION 1: That certain amended development agreement entitled
20 "Amended Development Agreement Between the City of Las Vegas and Cliffs Edge, LLC,"
21 which was approved by the City Council on November 18, 2009, and a copy of which is
22 attached, is hereby adopted in conformance with the provisions of NRS Chapter 278.

23 SECTION 2: The amended development agreement adopted by Section 1,
24 once reduced to writing in final form for purposes of execution and recordation, shall be
25 attached to this Ordinance and thereafter recorded in the office of the County Recorder in
26 accordance with the provisions of NRS Chapter 278.

27 SECTION 3: If any section, subsection, subdivision, paragraph, sentence,
28 clause or phrase in this ordinance or any part thereof is for any reason held to be

unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.
