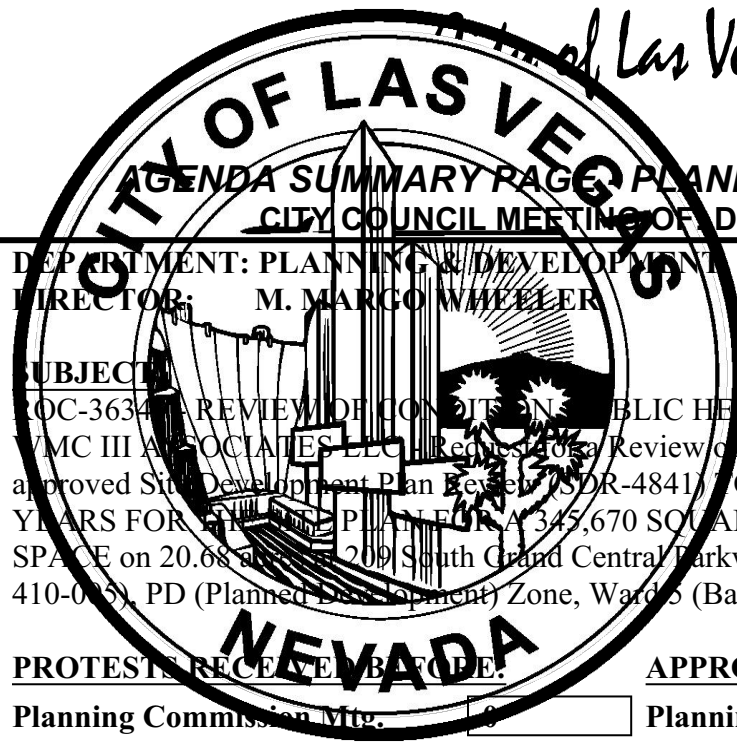

Under Item 66, MAYOR GOODMAN declared the Public Hearing open/closed for this item.

JOHN LELEU, 495 South Grand Central Parkway, appeared on behalf of the applicant. He
explained to COUNCILMAN BARLOW the requested extension of time is due to the downturn
in the economy. In 2004, the original Site Development Plan Review application was approved
for placement of tent facilities on site, and that application is due to expire at the end of 2009.
The applicant would like to defer further development until the economy improves. MR.
LELEU could not verify for the Councilman the life span of the tent facilities.
